## Activeport Secures Additional 125 Circuits in July Adding \$2M in Contract Value.

Activeport Group Ltd (**Activeport**) (ASX: ATV) launched its innovative Network-as-a-Service (NaaS) platform in May 2025, leveraging the high-performance FibreconX Pure Fibre network to deliver variable bandwidth connections between Australia's commercial centres to its major data centre hubs.

In June 2025, the company announced an initial take-up of 75 new circuits, adding up to \$1.2 million in contract value over 36 months. The company is now delighted to announce the booking of an additional 125 circuits in July 2025, bringing the total to 200 circuits since launch.

These new orders add another \$2 million in contract value over 36 months, taking the total to \$3.2 million in just the first two months since launch. The circuits will be deployed over the next 18 months, reflecting the rapid market adoption of Activeport's cutting-edge network orchestration software paired with FibreconX's state-of-the-art fibre infrastructure in the booming AI-driven market.

### Highlights:

- **200 NaaS circuits sold:** An additional 125 circuits booked in July, following 75 in June, together adding \$3.2 million of contract value over 36 months.
- **Revolutionary market impact:** The FibreconX Pure Fibre network, paired with Activeport's software, is transforming the commercial data communications market in Australia by enabling customers to purchase and manage network services with unprecedented flexibility and performance.
- **Early FY26 success:** With these orders, Activeport has already secured commitments for 50% of its FY26 budget within the first month of the financial year, positioning the company for significant growth.
- **Value-added services on the horizon:** From September, Activeport will roll out advanced services, including cloud access, network-to-network integration, and managed cybersecurity solutions, to further enhance customer value and drive incremental revenue growth.

### Unmatched Performance and Flexibility Driving Demand

The rapid take-up of FibreconX circuits by Activeport's dealer network highlights the market's enthusiasm for the high-performance, low-latency Pure Fibre network, combined with Activeport's self-service Global Edge portal. This powerful combination enables commercial customers to seamlessly order, manage, and scale network services across variable-rate 10GB ports, tailored to their specific bandwidth and service needs.

Activeport's Chairman & CEO, Peter Christie, commented: "The overwhelming response to our Global Edge NaaS platform, launched just two months ago, demonstrates the transformative power of Activeport's software when paired with FibreconX's state-of-the-art fibre network. Securing \$3.2 million in revenue commitments and achieving 50% of our FY26 sales target in just the first month of the financial year is a testament to the market's demand for high-performance, flexible, and cost-effective network solutions."

### Future Growth and Innovation

As Activeport deploys these 200 circuits over the next 18 months, the company will introduce a suite of value-added services, including cloud-on-ramps, network integration, and managed cybersecurity solutions, to meet the growing demand for secure edge-to-cloud connectivity. The planned integration of NBN services will further extend Activeport's reach, providing seamless Australia-wide coverage to complement FibreconX's metropolitan network in Sydney, Melbourne, and soon Brisbane.
