Answer: The Company is continuing its process to reduce operating cash flows, but it is expected that the current level of cash flows will be maintained for the next two quarters.

Answer: The Company has secured \$1,000,000 in additional funding through a structured financing arrangement. The arrangement consists of a \$600,000 convertible note facility and an additional R&D Loan of \$400,000. The Company has drawn down the R&D Loan of \$400,000 after the quarter end. The Company will continue to evaluate the options available to raise further cash to fund operations and believe that it is very likely that further cash will be secured as and when needed.

Answer: The Company believes that it will be able to continue its operations and meet business objectives.
