REPORT ON QUARTERLY ACTIVITIES TO ACCOMPANY APPENDIX 4C

Q4 FY25 – Operations

Net cash from operating activities was positive in the fourth quarter totalling \$133,000 and for the 12 months to 30 June 2025 totalled \$428,000. This favourable position resulted from one off events with the insurance claim settlement of \$500,000 (in the first quarter) and the net auction proceeds from the sale of recovered rental assets of \$191,000 (in the fourth quarter).

Cash on hand at 30 June 2025

The Company had funds / interest bearing deposits on hand totalling \$8.177m.

Payments to related parties of the entity and their associates

The amount disclosed in item 6.1 in the accompanying Appendix 4C relates to the payment of directors' fees.

The amount disclosed in Item 6.2 in the accompanying Appendix 4C relates to the payment of fees for legal services provided by Tobin King Lateef, which Mr Bede King is a partner.

Corporate activities

The Company is currently evaluating an acquisition prospect that satisfies a key requirement as well as meets other criteria of the Company.

Suspension of Securities

As previously advised to the market, SIV Capital Limited securities were suspended from quotation on 18 December 2024. ASX had determined at that time that SIV's operations were not adequate to warrant continued quotation of its securities and therefore the Company was in breach of Listing Rule 12.1 and further noting that until ASX could be satisfied the Company was in compliance with the Listing Rules, in particular Listing Rules 12.1 and 12.3, would not reinstate SIV's securities to quotation.

In the meantime, the Company will continue to release periodic disclosure to ensure the market is fully informed under Listing Rule 3.1-3.1B.
