**XTC Lithium Limited (ASX: XTC) (XTC, or the Company)** quarterly activities report for the quarter ended 30 June 2025.

#### ***SOUTH AMERICA – CARACHI PAMPA LITHIUM BRINE PROJECT (CARACHI PROJECT)***

As previously announced (ASX: 24 April 2025), XTC and American Battery Materials, Inc. (ABM), a Delaware-based corporation dedicated to advancing lithium resource development, advised that they have signed a non-exclusive non-binding Letter of Intent (LOI) outlining the principal terms of a proposed partnership to develop the Carachi Lithium Project in Argentina's Catamarca province. Under the terms of the LOI, ABM will have the opportunity to acquire up to a 50% interest in the Carachi Lithium Project, subject to the parties finalizing a definitive agreement and securing all necessary statutory, corporate, and regulatory approvals. Additionally, upon securing a 10% interest in the Project, ABM will have the right to enter into a joint venture agreement with XTC for the continued exploration and development of the tenements.

Management is continuing discussions with a number of other third parties familiar with Argentine operating conditions to support the Company's operations at the Carachi Pampa Lithium Brine Project.

#### ***Operations:***

The Company has engaged Grupo Territorio Sasu (GTS), in Catamarca. GTS will:

- Identify data to update the Environmental Impact Report (EIR)
- Identify and document necessary modifications to the Environmental Management Plan.

- Formulate a community communication plan.
- Implement the project's Geographic Information System (GIS).
- Define the Waste Management Plan.
- Incorporate the following surveys, a) Surface/groundwater, b) Waste, c) Biodiversity (limnological studies, flora, and fauna), d) Biodiversity Control Plan (PCA), and e) Archaeology, Update the EIR and submit the report.
- Update the Environmental Impact Report (EIR) and presentation of the report

The Company has sought tenders for a proposed drilling program and management of the Carachi Project following granted approval of EIA.

## **Western Australia – Southern Cross Gold Project**

On 28 February 2025 the Company announced that it had completed the sale of its non-core wholly owned exploration tenements at Southern Cross in WA. The sale was finalised post June 2025 quarter end.

### ***Carachi Lithium Project – Catamarca, Argentina***

*The Carachi Lithium Project is located in Catamarca Province, Argentina (the "Project") which is inside the world-renowned Lithium triangle in South America that covers areas of Argentina, Chile and Bolivia. The Project, which comprises 21,900 hectares, is situated 40 kilometres south of the town of Antofagasta de la Sierra, Catamarca, at approximately 3,000 metres elevation. This region of Argentina includes the Hombre Muerto Salar where a US\$840 million lithium mine is under development by the Korean multinational corporation POSCO. Livent Corporation has been producing lithium in the southwest part of Hombre Muerto for over 25 years, whilst Allkem Resources has a large development stage lithium Project in the south part of the Hombre Muerto salar. At the district level, the Carachi Project is adjacent to Lake Resources' Kachi lithium project that is well-advanced in its development stage.*

Answer: No, however exploration was primarily on the Southern Cross project which the Company sold in January 2025. Costs on this project will stop, proceeds of \$450,000 owing not represented in cash flow above and will be received in July 2025.

Answer:: Yes. The Company is in advanced discussions with a number of parties in relation to raising additional capital and funding operations in the immediate term. The Company has a high level of confidence of being able to raise sufficient capital to continue its operations.
