

## Scheme of Arrangement becomes legally effective

Further to the announcement made earlier today, Silk Logistics Holdings Limited (ASX:SLH) (**Silk** or the **Company**) confirms that it lodged an office copy of orders made by the Supreme Court of New South Wales (**Court**) approving the proposed acquisition of all of the shares in the Company by DP World Australia Limited (**DP World Australia**) by way of a scheme of arrangement (**Scheme**) with the Australian Securities and Investments Commission (**ASIC**) pursuant to section 411(10) of the *Corporations Act 2001* (Cth).

An office copy of the Court orders lodged with ASIC is attached to this announcement.

The Scheme is now legally Effective, and quotation of Silk Shares on the ASX will be suspended from the close of trading today.

It is expected that implementation of the Scheme will occur on Monday, 18 August 2025 (**Implementation Date**). On the Implementation Date, Silk Shareholders who have been recorded on the Silk Share Register as owning Silk Shares at 7.00pm (Sydney time) on Monday, 11 August 2025 (being the Scheme Record Date), will receive A\$2.14 cash consideration for each Silk Share they hold.

All times and dates remain subject to change. Any changes will be announced by Silk to ASX.
