Correction to Appendix 3X

Sigma Healthcare Limited (**Sigma**) advises that the attached Appendix 3X (Initial Director's Interest Notice) for Jack Gance replaces the Appendix 3X for Mr Gance that was lodged with the ASX on 13 February 2025.

Due to an administrative oversight, the previously lodged Appendix 3X (at the time of merger) inadvertently omitted 2,205 ordinary shares that are directly held by Mr Gance. Accordingly Mr Gance has interests in 1,579,052,263 Sigma shares and not 1,579,050,058 Sigma shares as originally disclosed. These shares were acquired by Mr Gance more than 20 years ago. As soon as the oversight was identified, steps were taken promptly to arrange for the corrected Appendix 3X to be lodged with ASX.

Sigma and the directors of Sigma are aware of their obligations under Listing Rules 3.19A and 3.19B to provide the information necessary for Sigma to meet its disclosure requirements. Sigma believes that its current arrangements are adequate to ensure compliance with these Listing Rules and considers this oversight to be an isolated incident.

Sigma confirms that Mr Gance did not vote these shares on any of the resolutions at Sigma's extraordinary general meeting on 29 January 2025.
