### Atturra completes acquisition of Blue Connections Pty Ltd

#### Key highlights:

- Atturra Limited (**Atturra**), through its subsidiary Cirrus Networks Holdings Pty Ltd (ACN 103 348 947), acquires Blue Connections Pty Ltd (ACN 630 573 349) (**Blue Connections**) (**Acquisition**).
- Blue Connections delivers a comprehensive suite of IT solutions through its state-of-the-art Network Operations Centre, supporting clients across Networking, Security, and Unified Communications & Collaboration.
- Blue Connections also partners with leading global vendors and is both a Microsoft Partner and a certified Microsoft Cloud Solution Provider, managing and billing Microsoft Azure Cloud solutions.
- Blue Connections provides IT procurement services across mid-market, enterprise and government sectors, including End User Compute, Device Lifecycle Management, Modern Workplace, Device as a Service, Bid Management, and Warehousing.
- Blue Connections also operates an Australian-based 24x7 Service Desk supporting customers and offering Level 1, 2, and 3 engineers.
- The upfront consideration is \$18m in cash, with earn-out/post-completion consideration of up to \$7.5m in cash or shares subject to Blue Connections achieving performance hurdles based on audited EBIT targets for FY26 and FY27 and retention of key staff. Integration costs have been budgeted at \$500,000.

**Sydney, 01 September 2025** – Atturra Limited (ASX: ATA), a leading technology services business in designing, implementing, and maintaining IT solutions, announces that its subsidiary, Cirrus Network Holdings Pty Ltd, has completed the acquisition of Blue Connections.

Blue Connections has been providing IT solutions and managed services since 1997. Its impressive Melbourne facilities include an experience centre, training centre, configuration zone and warehouse. It has a highly skilled team specialising in services, delivering end-to-end solutions including traditional on-premises infrastructure, virtualisation, consolidation, and disaster recovery and a full managed services offering.

#### CEO of Atturra, Stephen Kowal, said:

*“The acquisition of Blue Connections will significantly enhance Atturra’s credentials as a leading provider in managed services. It will strengthen Atturra’s service capabilities, while expanding its client base and portfolio of offerings. Notably, Blue Connections’ client roster has minimal overlap with Atturra’s, providing an opportunity to broaden Atturra’s revenue streams and market reach.*”
