Revenue Allocation by Region

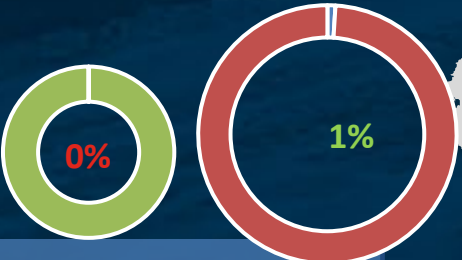
Sales Split by Worldwide Markets Geographies – FY25 & FY26



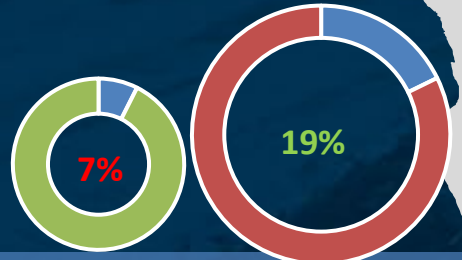
