# Pioneering Perth material technology companies form carbon collaboration

## Highlights

- FGR has entered an MOU with Hazer Group Limited
- Collaboration will explore material processing and carbon-based product synergies
- Potential to expand FGR's carbon-based product range outside of existing PureGRAPH<sup>®</sup>

First Graphene Limited (ASX:FGR; "First Graphene" or "the Company") has entered a Memorandum of Understanding ("MOU") with Perth-headquartered Hazer Group Limited ("ASX:HZR" or "Hazer").

The MOU will allow both pioneering companies to explore carbon-based material processing and product synergies, with a view to potentially expanding FGR's range of products outside of its flagship PureGRAPH<sup>®</sup> range.

Under the MOU, Hazer will provide FGR samples and information relating to the properties of HAZER<sup>®</sup> Process graphite that has been produced from its commercial demonstration plant in Munster, Western Australia.

First Graphene will assess HAZER<sup>®</sup> Process graphite and identify potential applications in First Graphene's hybrid graphene/graphite or larger size carbon additive supply portfolio.

Potential commercial options are to be explored following assessment and testing in relation to supply and offtake agreements for the same graphite.

*"This collaboration brings two world-class organisations based in Western Australia together, with a focus on producing high value carbon-based materials that complement each other's existing product portfolio.*

*We're excited to begin assessing and testing HAZER<sup>®</sup> Process graphite samples very soon to see if their materials have a place in our product line-up.*

*Our collaboration could also open the door to more joint research and development opportunities as uptake of natural and synthetic carbon-based materials accelerates globally."*
