



TALLEBUNG TIN PROJECT, NSW – EXPLORATION UPDATE

NEW HIGH-GRADE TIN, SILVER AND TUNGSTEN ZONES AT TALLEBUNG

MORE OUTSTANDING SHALLOW DRILLING RESULTS HIGHLIGHT STRONG GROWTH POTENTIAL

- Significant new zones of **shallow, high-grade tin-silver mineralisation intersected**, including:
 - TBRC216: **40m @ 0.24% tin & 26.6g/t silver** from 31m, including:
8m @ 0.55% tin & 120g/t silver from 42m.
 - TBRC201: **2m @ 4.28% tin** from 16m.
 - TBRC195: **12m @ 0.26% tin & 85.6g/t silver** from 13m, including:
1m @ 1.41% tin & 341g/t silver from 14m.
- **New high-grade tungsten-silver-tin zone** identified in the north-west of the deposit, with results including:
 - TBRC218: **6m @ 1.32% tungsten, 20.2g/t silver & 0.10% tin** from 21m,
10m @ 0.60% tungsten, 80.6g/t silver & 0.10% tin from 53m, including:
3m @ 1.58% tungsten, 173g/t silver & 0.18% tin from 60m.
- Tungsten is a critical mineral and typically trades at well over US\$30,000/t¹, with prices increasing steadily as demand tightens as a result of recent Chinese export bans.
- **Over 140 RC drill holes completed** in the recent program, with **a further +100-hole follow-up program planned to expand new high-grade discoveries** and in-fill the Tallebung deposit.
- **Drilling expected to re-commence next month**, once approvals are received.
- Additional assay results pending, with further updates to be released over the coming weeks.

SKY Managing Director & CEO Oliver Davies commented: *“These latest results continue to demonstrate the scale and quality of the Tallebung Project. The identification of multiple new zones of shallow, high-grade tin and silver mineralisation, together with the emergence of new high-grade tungsten-silver zones in the north-western part of the deposit, significantly enhances its development potential.*

“With over 140 holes completed in this latest drilling program, more results still pending, and approvals already submitted for a major follow-up program commencing next month, we are rapidly advancing the Tallebung Tin Project towards development as a significant new Australian critical minerals asset.”

Sky Metals Limited (ASX: SKY) ("SKY" or "the Company") is pleased to report further excellent assay results from the recently completed Reverse Circulation (RC) drilling program at its 100%-owned **Tallebung Tin Project** in NSW.

These latest results continue to expand the mineralised footprint of the deposit and confirm the presence of multiple new zones of shallow, high-grade tin, tungsten and silver mineralisation.

TALLEBUNG PROJECT (EL 6699, SKY 100%)

TALLEBUNG RC DRILLING CONTINUES TO INTERSECT SHALLOW, HIGH-GRADE TIN-SILVER ZONES

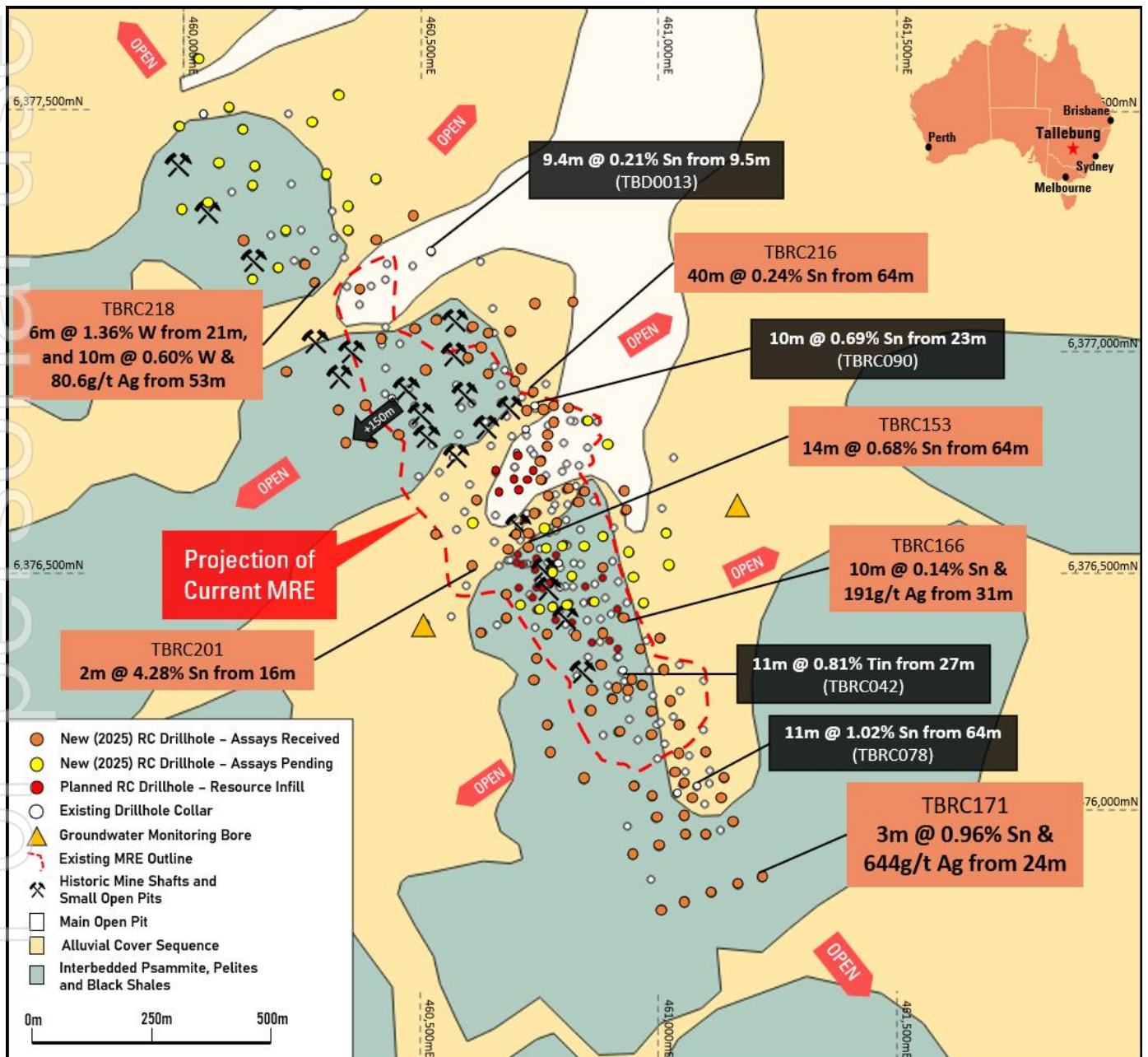


Figure 1: Plan showing the location of the drill-holes in the latest program, including new assay results, new extensional drill-holes with assays pending, and selected previously reported highlight drill intercepts. The boundary of the existing Tallebung MRE is also shown over surface geology.

The recently completed, highly successful Reverse Circulation (RC) drilling program at the Tallebung Tin Project has returned further strong results, confirming the presence of multiple new zones of shallow, high-grade tin, silver and tungsten mineralisation. These results continue to expand the mineralised footprint of the deposit and support the potential for a significant upgrade to the deposit tonnage and tenor (see Figure 1).

Drill-hole TBRC216 intersected a broad zone of mineralisation with 40m @ 0.24% Sn & 26.6g/t Ag from 31m, including a high-grade interval of 8m @ 0.55% Sn & 120g/t Ag from 42m. This intercept is located on the new eastern extension of the deposit and demonstrates the continuity of shallow mineralisation in this new higher-grade zone discovered in the latest drilling program.

Additional high-grade intercepts include TBRC201, which returned 2m @ 4.28% tin from 16m, which has discovered high-grade mineralisation on the western edge of the known deposit footprint, further expanding the deposit and demonstrating that additional higher-grade zones are yet to be discovered beyond the known extent of the deposit.

In-fill continuity has also been established with TBRC195, which intersected 12m @ 0.26% tin and 85.6g/t silver from 13m, including a peak interval of 1m @ 1.41% tin and 341g/t silver from 14m. These results confirm the presence of multiple stacked mineralised zones within the upper levels of the deposit.

NEW HIGH-GRADE TUNGSTEN-SILVER ZONE EMERGING IN NORTH-WEST TALLEBUNG

Drilling in the north-western extension of the Tallebung deposit has identified a new zone of high-grade tungsten-silver-tin mineralisation. TBRC218 returned 6m @ 1.32% W, 20.2g/t Ag & 0.10% Sn from 21m, and 10m @ 0.60% W, 80.6g/t Ag & 0.10% Sn from 53m, including a standout interval of 3m @ 1.58% W, 173g/t Ag & 0.18% Sn from 60m.

This emerging zone confirms the excellent polymetallic potential of the Tallebung mineral system. The high-grade tungsten and silver grades are particularly encouraging for future by-product extraction of tungsten and silver to bolster the significant tin production already planned at Tallebung.

EXTENSIVE DRILLING PROGRAM COMPLETED, SUBSEQUENT LARGE FOLLOW-UP PROGRAM IMMINENT

A total of 143 RC drill-holes were completed as part of the recent successful program, with a further +100-hole follow-up program already planned with approvals submitted and planned to commence in the coming weeks.

This next phase of drilling is designed to expand and in-fill the new zones of high-grade mineralisation discovered in the latest program. The Company's strategy is to continue to grow the Mineral Resource base to optimise mining studies and development planning.

Remaining assays from the final holes in the latest program are pending and will be released as they are received over the coming weeks.

About the Tallebung Tin Project (100% SKY)

Tallebung stands as an open-pit, technology enabled, near-term tin development project. Tallebung is uniquely placed to provide secure tin supply, to feed irreplaceable and rapidly expanding tin demand, essential in semi-conductors, electronics and solar PV technologies.

The Tallebung Tin Project is located at the site of large-scale historical tin mining in central Western NSW where tin was first discovered in the 1890s. SKY is progressively defining a large-scale hardrock tin resource with recent higher-grade tin zones discovered on the margins of the known deposit and exceptional metallurgical performance demonstrated across the entire known deposit.

The shallow, open-pit tin veins combined with the ideal nature of the tin, hosted as large, discrete grains of simple tin-oxide (cassiterite minerals), all ideally lends itself to low-cost tin production advantages, including exceptional X-ray based ore sorting performance, demonstrated to upgrade the tin up to **44x**, prior to low-cost gravity separation to produce a saleable tin concentrate.
