**COBALT BLUE HOLDINGS LIMITED – REQUEST FOR TRADING HALT**

Pursuant to ASX Listing Rule 17.1, Cobalt Blue Holdings Limited (ASX: COB) ('the Company') requests a trading halt in its ordinary shares to apply with immediate effect today, Wednesday, 10 September 2025.

The Company provides the following information for the purposes of ASX Listing Rule 17.1:

- a) The trading halt is requested in connection with a potential capital raising (**Capital Raising**). The trading halt is necessary to assist the Company in managing its continuous disclosure obligations prior to the Company making an announcement regarding the Capital Raising and to prevent trading taking place on an uninformed basis.
- b) The Company requests that the trading halt remain in place until the earlier of:
  - i. The Company making an announcement to ASX regarding completion of the Capital Raising; or
  - ii. The commencement of trading on Friday, 12 September 2025.
- c) The Company expects that the trading halt will end once the Company makes an announcement to ASX in relation to completion of the Capital Raising (which is expected no later than commencement of trading on Friday, 12 September 2025; and
- d) The Company is not aware of any reason why the trading halt should not be granted or any other information necessary to inform the market about the trading halt.

The trading halt request has been approved by the Company's Board of Directors.
