Section 259C Exemption Notice - MQG

Macquarie Group Limited (Macquarie) has been granted relief from section 259C of the Corporations Act 2001 (Cth) relating to certain acquisitions of Macquarie shares by Macquarie Group companies ("Exemption").

In connection with the Exemption we notify that as at 8 September 2025:

(A) The number of voting shares of Macquarie in respect of which it or its controlled entities (referred to in Annexure B) have the power to control voting or disposal expressed as a percentage of the total number of voting shares of Macquarie is 6.37%, of which 4.07% relates to employee share plans. Details regarding these voting shares are set out in Annexure A. For details of any relevant agreement through which the power arose and that is not attached to this form, please refer to our previous substantial holder notices and s259C notices.

(B) The number of voting shares of Macquarie that underlie derivatives held by Macquarie or its controlled entities for the purposes of hedging its obligations to employees under an employee incentive scheme expressed as a percentage of the total number of voting shares of Macquarie is 0.090%.

(C) The number of voting shares of Macquarie in respect of which it or its controlled entities have a net economic exposure as defined in the Exemption (excluding any voting shares reported under (B) above), expressed as a percentage of the total number of voting shares of Macquarie is -0.003%.

The Exemption was lodged with ASX on 9 August 2024. Macquarie was last required to disclose to ASX details of these aggregate percentages with respect to voting shares of Macquarie on 6 June 2025. The previous notice was dated 11 June 2025. Annexures A and B are attached in this disclosure document.
