TMK Energy Limited (ASX: **TMK** or the **Company**) requests an immediate trading halt of its securities listed on the ASX, from the commencement of trading on Thursday 11 September 2025 (**Trading Halt**).

In accordance with ASX Listing Rule 17.1, TMK provides the following information:

- The reason for the trading halt is to allow TMK to manage its continuous disclosure obligations whilst it undertakes a capital raising;
- TMK requests the trading halt to continue until the earlier of the commencement of normal trading on Monday 15 September 2025, or the release of an Announcement by the Company in relation to the capital raising;
- TMK is not aware of any reason why the Trading Halt should not be granted; and
- TMK is not aware of any other information necessary to inform the market about the Trading Halt.
