EGL Baltec Secures New \$9.3M Contract

The Environmental Group Limited (ASX: EGL) ('the Company') is pleased to announce another major contract win for EGL Baltec for the engineering, design, and supply of two large Gas Turbine Diverter Bypass Exhaust Systems to Spanish EPC TSK for the 800MW Manzanillo Energy Consortium Power Plant Project located in the Dominican Republic. EGL Baltec will undertake this work over the next 12 months with delivery expected in September 2026. The project is exciting in supplying much needed power to the Dominican Republic including a bypass stack to enable operation in peaking mode, giving the client more operating flexibility. Our unique silencer design has been able to meet the stringent noise limit requirements whilst optimising turbine performance.

Gas Turbines are widely used to support the Renewable-Energy Sector by supplementing peak load energy requirements. This requires the turbine to be able to deal with the thermal dynamics of heating and cooling into the thousands of cycles. Coupled with mechanical and structural design, our silencer technology has brought together a world class product.

EGL CEO Jason Dixon said, "This project builds on EGL Baltec's expertise in the field of acoustic technology, including silencer design and noise measurements, and operational flexibility. There will be further similar opportunities in future with clients looking for improved operation flexibility of proposed combined cycle power plants that enables the use of high efficiency large gas turbines to provide power backup for large scale renewables."

Securing this project brings the value of contracts won by EGL Baltec year to date to approximately \$19.7M, setting EGL Baltec up for strong performance in the current and following financial year.
