### Appointment of Executive Chairman, Executive Director and CEO Transition

Frontier Digital Ventures Limited ("FDV" or the "Company") is pleased to announce the following Board and management changes, effective immediately:

- Patrick Grove has been appointed as Executive Chairman

- Shaun Di Gregorio will continue as Chief Executive Officer until his final day on 30 November 2025, after which he will transition to the role of Non-Executive Director of the Company. #### **Remuneration and Terms**

Patrick Grove and Lucas Elliott will, in aggregate, receive a base fee of A\$50,000 per month, subject to annual review, and waive their director's fees as current Board members. Either party or the Company may terminate the executive relationship with six months' written notice.

In addition, the Company intends to put forward an equity incentive plan for both Patrick Grove and Lucas Elliott for shareholder approval in the near future. In the event the proposed equity plan does not receive shareholder approval, either party may terminate the executive relationship with immediate effect.

FDV Executive Chairman Patrick Grove said:

"I am excited to step into the role of Executive Chairman alongside Lucas Elliott as Executive Director. Together we will continue to drive FDV's mission of building and scaling leading digital marketplaces in frontier markets globally. On behalf of the Board, I also thank Shaun for his outstanding leadership since FDV's inception and look forward to his continued contribution as Non-Executive Director."
