### **Completion of Merger with L1 Capital**

Platinum Asset Management Limited (ASX:PTM) ("**Platinum**") is pleased to announce the completion of its merger with First Maven Pty Ltd ("**L1 Capital**") in accordance with the terms of the Merger Implementation Deed released to the ASX on 8 July 2025 (the "**Merger**"). Platinum has acquired all of the Class A, Class B, Founder and ordinary shares in L1 Capital, in consideration for the issue of 1,656,937,177 new fully paid ordinary shares in Platinum (the "**New Platinum Shares**") to the shareholders of L1 Capital.

### **Anticipated change of name and ASX ticker**

Platinum's name will change from "Platinum Asset Management Limited" to "L1 Group Limited". Once the name change is effective, Platinum will request that ASX change its ASX ticker from "PTM" to "L1G". Platinum will make an announcement to the ASX when such change has been completed.

### **Changes to Board of Directors**

With effect from completion of the Merger, Ms Anne Loveridge AM, Mr Philip Moffitt and Mr James Simpson have resigned as directors of Platinum.

Mr Neil Chatfield and Ms Jane Stewart have been appointed as new directors of Platinum with effect from today.

The Board now comprises Mr Guy Strapp (Chair), Mr Jeff Peters (Managing Director), Ms Rachel Grimes AM, Mr Neil Chatfield and Ms Jane Stewart.

### **Escrow arrangements**

The New Platinum Shares issued to the L1 Capital shareholders at completion of the Merger are subject to voluntary escrow arrangements, subject to customary exceptions. The escrow arrangements provide that:

- 25% of New Platinum Shares held by each L1 Capital shareholder will be escrowed for two years immediately following completion;
- 25% of New Platinum Shares held by each L1 Capital shareholder will be escrowed for three years immediately following completion; and
- the remaining 50% of New Platinum Shares held by each L1 Capital shareholder will be escrowed for four years immediately following completion.

The table below summarises the application of all escrow arrangements that will apply to the New Platinum Shares from completion.
