

Battery Age Minerals Moves to 100% Ownership of Falcon Extension Properties, Ontario

Full ownership of the Falcon Extension properties further strengthens Battery Age's control and long-term growth platform across the highly fertile Falcon Lake Lithium Project

Highlights

- **100% ownership achieved:** Battery Age has exercised its option to secure the remaining 20% interest in the Falcon Extension Properties in Ontario, Canada.
- **Located on proven lithium ground:** The Falcon Extension sits within the Caribou O'Sullivan Greenstone Belt, the same belt that hosts Battery Age's exceptional lithium intercepts such as **54.1 m @ 1.74% Li₂O** and **55.95 m @ 1.47% Li₂O**.
- **Multi-Element Critical Mineral Potential Confirmed:** Assays across the Falcon Lake Project have returned high concentrations of **rubidium (up to 11,400 ppm)**, **caesium (up to 2,600 ppm)**, **tantalum (up to 2,300 ppm)** and **gallium (up to 95.6 ppm)**, underscoring the Project's broader critical-minerals potential.
- **Favourable terms:** Completion of the acquisition follows the staged option agreement with Ombabika Group Inc., originally executed in 2023, involving a mix of cash and share consideration.
- **Exploration Upside:** Only 5 of the 30 high-priority targets identified through geophysical surveys and surface sampling have been drill tested, leaving substantial scope for further discoveries.

Battery Age Minerals Ltd (ASX: **BM8**; "**Battery Age**" or "**the Company**") is pleased to advise that it has completed its earn-in and exercised the final stage of its option agreement ("**Agreement**") to secure 100% ownership of the Falcon Extension Properties in Ontario, Canada.

The Falcon Extension properties, acquired under option in October 2023, strategically link Falcon Main and Falcon North to form a single, contiguous 51 km² project area. Since the initial acquisition, Battery Age has conducted extensive fieldwork and multiple drill campaigns confirming the fertility and scale potential of the broader Falcon Lake corridor.

Recent drilling at Falcon Little Lake, located within the consolidated land package, returned multiple thick, high-grade spodumene-bearing pegmatite intercepts including 54.1 m @ 1.74% Li₂O and 55.95 m @ 1.47% Li₂O, representing the Company's best results to date (ref ASX announcement 28 January 2025). The mineralised system remains open along strike and at depth, highlighting the significant growth potential of the project.

Beyond lithium, Battery Age's analysis of multi-element assays from the Falcon Lake Project has confirmed significant enrichment in several high-value critical metals, including rubidium, caesium, tantalum and gallium within the spodumene-bearing pegmatites. These results reinforce Falcon Lake as not only a prospective hard-rock lithium project, but also a potentially strategically significant, multi-element system comparable to other evolved LCT pegmatite districts across Canada. The combination of scale, grade and multi-commodity potential further enhances the long-term strategic value of Battery Age's consolidated Falcon Lake portfolio.

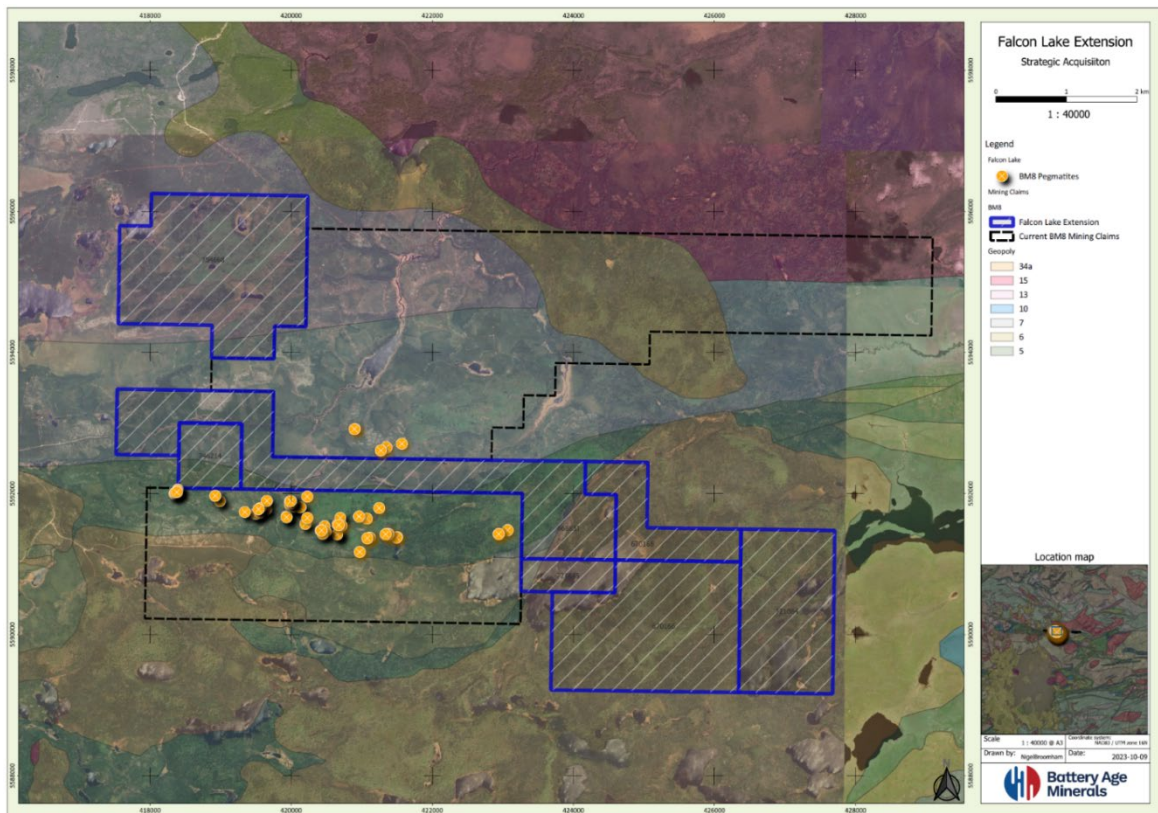


Figure 1 - Falcon Extension properties in blue part of the larger Falcon Lake package

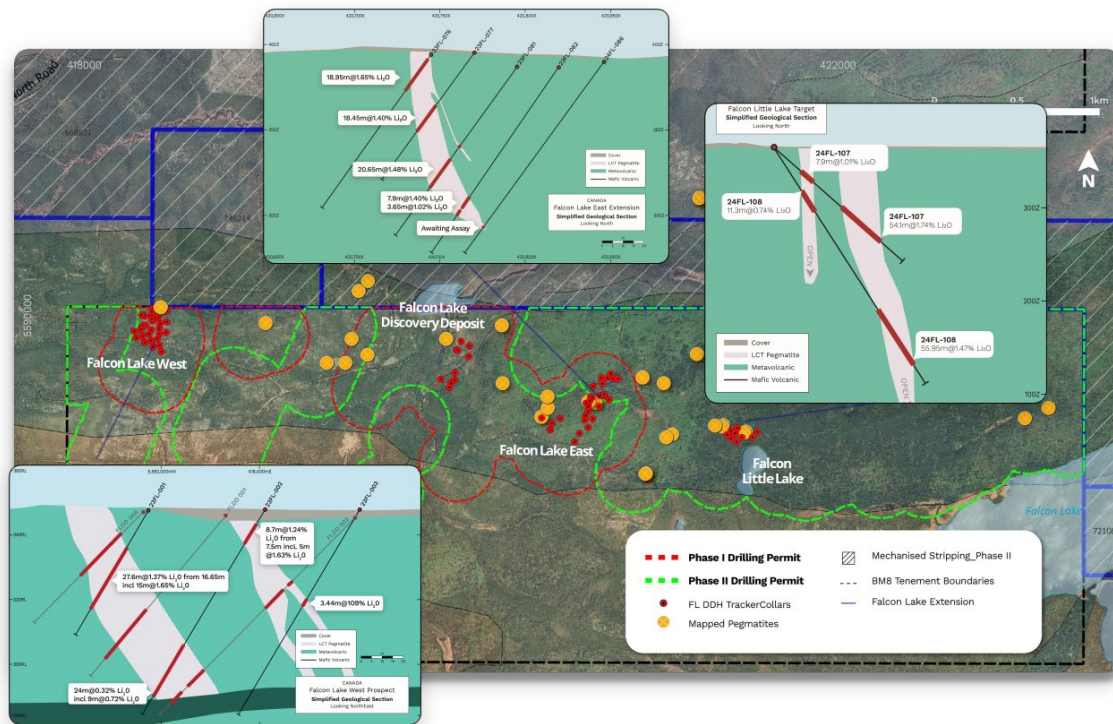


Figure 2 - Falcon Lake drilling (2023-2024) and drill targets

The Company has completed the final stage 3 option to move from 80% to 100% ownership of the Falcon Extension properties, in consideration for the pre-agreed payment of CAD\$15,000 and the issue of 250,000 BM8 shares at an issue price of \$0.40 per share (Stage 3 Earn In) (for full details refer to announcement dated 10 October 2023).

This strategic approach complements BM8’s significant exposure to battery and critical minerals, including the Company’s highly strategic Bleiberg Germanium-Zn Project.”
