### **Response to media article**

Accent Group Limited (**Accent or the Company**) refers to the recent media article published in the Australian Financial Review regarding the waiver granted by ASX from ASX Listing Rule 6.23.3, which incorrectly states that the waiver applies to the Tranche 8 performance rights held by Accent's CEO and Managing Director, Daniel Agostinelli.

As disclosed in Accent's ASX announcement dated 8 October 2025, Accent clarifies that the waiver granted by ASX from ASX Listing rule 6.23.3 applies only to the Tranche 8 performance rights held by Accent employees other than Mr Agostinelli.

Further, Accent confirms that the proposed variation to the performance condition attaching to those Tranche 8 performance rights will be subject to shareholder approval at Accent's upcoming 2025 Annual General Meeting.

Details of the proposed variation is disclosed in Accent's ASX announcement dated 8 October 2025.
