New uranium mineralisation discovered adjacent to Alta Mesa Uranium Project

Boss Energy Limited (ASX: BOE; OTCQX: BQSSF) advises that enCore Energy Corp (NASDAQ: EU; TSXV: EU) (**enCore**) has published an update on new uranium discoveries made near existing wellfields at the Alta Mesa Uranium Project in Texas, US.

enCore is the operator and 70 per cent-owner of the Alta Mesa Uranium Project in Texas. Boss owns the remaining 30 per cent of the project and receives 30 per cent of the mine's uranium production.

In its update, enCore said the additional roll front uranium mineralisation had been discovered as a result of a major ongoing re-analysis of historic drill holes from across the Alta Mesa Project.

This re-analysis of previous drill data is expected to continue until the end of the year with follow-up delineation drilling continuing into 2026. This drilling is in addition to the major drill program, expected to commence in the next few weeks, on the recently acquired Alta Mesa East Property (formally called Tacubaya).


