## Response to cyber incident

**17 October 2025** – ReadyTech Holdings Limited (ASX:RDY) (**ReadyTech** or **Company**), has become aware of a cyber incident involving its hosted student management system, VETtrak (**Platform**).

On detecting the incident, ReadyTech immediately isolated the Platform as a precautionary measure and engaged external experts to assist with managing our response to the incident. Access to the Platform by customers is expected to be temporarily unavailable for a period as we work to bring systems back online.

An investigation has been launched and ReadyTech continues to work with external experts to determine the extent of the incident and its impacts. At this stage, we are not aware of any impact beyond the affected Platform, however we are monitoring out of an abundance of caution.

The security and privacy of our customer data is our highest priority. We are focussed on identifying whether there has been any unauthorised access to any information we hold.

As a precaution, ReadyTech has notified the Australian National Office of Cyber Security (NOCS) and Australian Cyber Security Centre (ACSC) and continues to work with them as part of our response to the incident.

Further updates will be provided to all relevant stakeholders as more information becomes available in accordance with ReadyTech's commitment to our customers and stakeholders as well as our continuous disclosure obligations.
