CONNEQT Pulse Sales Update

CONNEQT Health Limited (ASX: CQT) (“CONNEQT” or “the Company”) is pleased to provide an update on sales of its CONNEQT Pulse arterial health monitor, following its successful commercial launch earlier this year.

Since launch in January 2025, the CONNEQT Pulse has continued to deliver accelerating sales growth, reflecting increasing consumer adoption and expanding clinical awareness.

Key highlights through to the end of the September Quarter include:

- Over 50% quarter-on-quarter sales growth since launch.
- September Quarter sales: US\$325k, with a significant improvement in return on advertising spend.
- Annualized revenue run-rate now exceeding US\$3.5 million (A\$5.4 million).
- Expected further sales acceleration in Q2 FY26, supported by seasonal demand and upcoming marketing initiatives.

Commensurate with the sales growth and expanding market traction, the Company has placed a new purchase order for 10,000 additional Pulse units with its supply partner to meet increasing demand.

Craig Cooper, CEO, CONNEQT Health commented:

“In less than three quarters, we’ve scaled sales of the Pulse from zero at the start of the year to over A\$5 million in annualized run-rate revenue. That kind of growth speaks volumes about both the demand and the market opportunity for our advanced arterial health monitors - and validates our vision to make clinical-grade cardiovascular insights accessible to everyone.”

With Pulse revenues continuing to build, CONNEQT enters Q2 FY26 with strong sales momentum, an expanding installed base and growing consumer and clinical brand awareness. The Company remains focused on scaling production, optimizing marketing efficiency and introducing additional subscription and data-driven features to further enhance recurring revenue opportunities.
