Collie land acquisition and development approvals move ahead

International Graphite Limited (ASX: IG6) (FWB: H99) continues to achieve key milestones in the development of Australia's first commercial graphite micronising facility at Collie, Western Australia.

Land acquisition: A land sale contract has been executed with DevelopmentWA for ~6,000 square metres of land covering three lots in the Collie Light Industrial Area². The site is opposite the Company's existing R&D facility.

Approvals: A development application has been lodged with the Shire of Collie and a power application has been submitted to Western Power to secure electricity supply sufficient for both the initial and expanded production capacity of up to ~7,500 tonnes of micronised product per annum.

Detailed design of the plant with local contractors ProsserBuilt is ongoing and is expected to be completed during the development approval period.

Managing Director and CEO Andrew Worland said: "Land of this quality is rare as industrial and residential development in the south-west region of Western Australia continues to boom. The addition of our infrastructure will create a property value well in excess of its sunk cost."

and manufacturers keen to secure local supply and avoid extended delays in sourcing graphite from overseas. Several companies are testing our products for suitability in their manufacturing processes.”

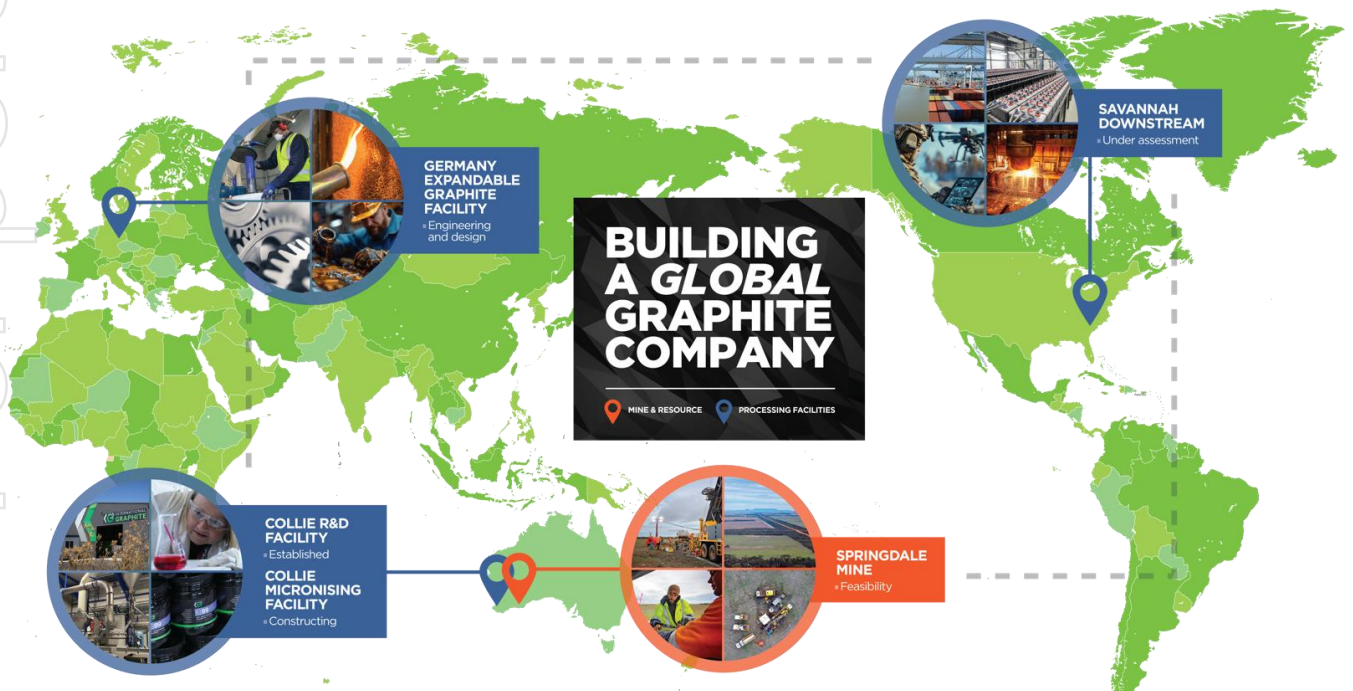
