**McGrathNicol Restructuring appointed Voluntary Administrators of PPG**

McGrathNicol Restructuring today announced the appointment of Partners Keith Crawford, Rob Smith (AU entities only), Andrew Grenfell (NZ entities only) and Kare Johnstone (NZ entities only) as Joint and Several Voluntary Administrators (**Administrators**) of ASX-listed Pro-Pac Packaging Group (**PPG**). The Administrators will work closely with PPG's employees, suppliers, customers, financiers and other stakeholders to stabilise operations.

McGrathNicol Partner and Administrator Rob Smith said: *"We are urgently engaging with key stakeholders to maximise the prospect of successfully completing a sale or recapitalisation of PPG, or sales of its various business units. We are exploring all options that offer continued employment for PPG's workforce, and enable the business to continue producing high-quality packaging solutions for domestic and international customers."*

**First statutory meeting of creditors**

A first statutory meeting of creditors must be held within eight business days after the administration begins and is expected to take place by Monday 3 November 2025. Meeting notices setting out the time and location for the first meeting of creditors will be distributed to PPG's creditors over coming days.
