

## September 2025 Quarterly Activities Report

### KEY HIGHLIGHTS

#### MINIM MARTAP BAUXITE PROJECT

- Definitive Feasibility Study (DFS) and Ore Reserves Upgrade confirms the Minim Martap Project as a world-class, tier-one bauxite asset with initial capex cost <US\$100M to first bauxite shipment in Q2, 2026
- Results highlighted the world-class and long-life characteristics of the venture, with project NPV >US\$830M and an IRR of 29%.
- DFS coincided with a 33% increase in DSO (Direct Shipping Ore) grade Ore Reserves to 144Mt of ore at 51.2% Al<sub>2</sub>O<sub>3</sub> and 1.7% SiO<sub>2</sub> over 20 year mine life.
- High alumina grade of >51% and low silica content to command a long-term price premium of up to US\$11/t over Guinea Standard bauxite.
- Commencement of construction for \$100M capex project incorporating:
  - earthworks for Inland Rail Facility (IRF)
  - upgrades to ore haulage access road from mine to IRF
  - orders placed for delivery of first locomotives and wagons to arrive Douala Q1, 2026
  - mining contractor to mobilise to site in December 2025
  - engineering work for upgrades to Port du Bois in Douala commenced
- First bauxite shipment scheduled for Q2, 2026.

#### FINANCING

- Tranche 1 of Strategic Funding Package raising A\$35.6 million (before costs) completed subsequent to Quarter-end.
- Total equity funding package comprised of a two-tranche placement, raising approximately A\$205 million including options exercised by major shareholder Eagle Eye Asset Holdings ("EEA") to raise approximately A\$10 million.
- Afriland Bourse & Investissement (a wholly owned subsidiary of Afriland First Bank, which is the largest financial services group in Cameroon) ("Afriland") committed to subscribing approximately A\$70 million, subject to various in-country approvals and shareholder approval.
- EEA to maintain its shareholding at 56.5% and Afriland will emerge as a 10.1% shareholder in Canyon.
- The Company completed the first drawdown of ~US\$26 million from its US\$140 million Credit Facility with AFG Bank Cameroon with funds to be used towards the purchase of rolling stock and key infrastructure at Minim Martap.

#### CORPORATE

- Mr Peter Secker assumed the position of Chief Executive Officer effective from 1 July 2025, having previously supported the Company as a technical advisor since February 2025.
- Canyon strengthened the Company's Board with the appointment of Ms Adjou Ait Ben Idir as Non-Executive Director effective from 14 July 2025.
- Cash balance of A\$30.8M as at 30 September 2025.

## UPCOMING MILESTONES

- Ore Reserve estimates for Makan and Ngoundal – to be completed during H2, 2025
- First mining operations on site – Early 2026
- First bauxite shipment – Q2, 2026
- Completion of alumina refinery Feasibility Study – Q3, 2026

Canyon Resources Limited (**ASX: CAY**) ("**Canyon**" or "**the Company**") is pleased to report on its activities at the Minim Martap Bauxite Project ("**Minim Martap**" or "**the Project**") in Cameroon, for the quarter ended September 30, 2025 ("**the Quarter**").

### MINIM MARTAP BAUXITE PROJECT

#### Definitive Feasibility Study Outcome

During the Quarter, the Company released a Definitive Feasibility Study (DFS) and Ore Reserves Upgrade for the Minim Martap Bauxite Project<sup>1</sup>. The DFS results and the Ore Reserves Upgrade, solidified Minim Martap as a world-class bauxite operation confirming the Project's strong economics and outlining a pathway for the phased development, underpinned by an NPV of US\$835M, and an IRR of 29%. The study further validated the Company's commitment to a staged approach to operational progress, representing a major economic opportunity for Cameroon.

The release of the DFS coincided with an updated Mineral Resource Estimate of 1,102 Mt at 45.3 Al<sub>2</sub>O<sub>3</sub> and results of an Ore Reserve Update for the Project. The Ore Reserve estimate was increased by one third to 144Mt of DSO grade ore at 51.2% Al<sub>2</sub>O<sub>3</sub> and 1.7% SiO<sub>2</sub>, and which will underpin the long-term future of Minim Martap. The study also found high alumina grade of >51% and low silica content to command a long-term price premium of up to US\$11/t over Guinea Standard bauxite, with first bauxite shipment planned for H1 2026.

Canyon commenced early works for the Project, including the construction of the Inland Rail Facility (IRF) that will be used to transfer ore from road to rail, the upgrade of the haul road to transfer ore to the IRF and the procurement of long lead items such as locomotives for rail haul.

During the Quarter, the Company also completed the first drawdown from its Credit Facility from AFG Bank Cameroon (AFG) (~US\$140M)<sup>2</sup>, and equity from an options exercise by Eagle Eye Asset Holdings Pte Ltd (EEA) (A\$25.4M) with funding being allocated to long lead items and the Project's Stage 1 CAPEX of US\$96M.

#### Construction of IRF and Upgrade of Ore Haulage Road

Construction of the Inland Rail Facility (IRF) at Makor commenced in July, which represents a key piece of infrastructure that underpins the export supply chain for Minim Martap<sup>3</sup>.

A ground-breaking ceremony at the site was attended by senior government members, including community members, Canyon Executive Chairman Mr Mark Hohnen, and Canyon cornerstone investor Eagle Eye Asset Holdings Pte. Ltd. Construction of the IRF commenced just months after the Company received approval from the Cameroon Government for the site location, demonstrating its commitment to fast-tracking development of the Project.

During the Quarter, the Company had the honour of welcoming Cameroon's Prime Minister, His Excellency Joseph Ngute, to the Minim Martap Project site for a series of official engagements, the most recent of which followed the announcement of the Company's A\$215 million strategic funding package.

During the previous quarter, the Company placed orders for locomotives from CRRC Ziyang Co. Ltd (CRRC) and wagons from Texmaco Rail & Engineering Limited (Texmaco). The initial payments have secured commitment of the key long lead items with CRRC and Texmaco, with first deliveries expected in Q1 2026 in line with the scheduled first bauxite shipment in 1H 2026.

During the Quarter, the Company commenced its upgrades of the ore haulage access road which connects the Minim Martap Project to the IRF at the Port of Douala. The Company has secured rail access from Makor to the Port of Douala, and 65,000 m<sup>2</sup> of land for the storage and loading of bauxite at the port. This will enable the Company to efficiently store and transport up to 6Mtpa of bauxite ore, which the Company intends to ultimately expand to 10Mtpa in line with increased production at Minim Martap.

### Looking Ahead

Canyon has made significant progress de-risking operations at Minim Martap, with a strong commitment to achieving near-term operational objectives. Key focus areas for the coming months include:

- Mining permits for Makan & Ngaoundal - Q4, 2025
- Offtake negotiations – Q1, 2026
- Start of mine production – Early 2026
- First bauxite shipment – Q2, 2026

### CORPORATE

#### Investor webcast

On 1 September 2025, CEO Peter Secker delivered a presentation outlining the DFS results and provided an overview of the Minim Martap project as it progresses towards expected production in early 2026. Shareholders and interested stakeholders are invited to view a recording of the presentation via the Company's website.

#### Commencement of Chief Executive Officer

Mr Peter Secker was appointed as Chief Executive Officer (CEO) effective 1 July 2025 after serving in the capacity of technical advisor since February 2025.

#### Appointment of Non-Executive Director

Ms Adjou Ait Ben Idir was appointed to the Board of Directors effective 14 July 2025, bringing extensive experience across globally listed companies complemented by legal expertise focused on driving business growth and leading corporate transformation.

#### Financial Position

Subsequent to Quarter-end, Canyon completed Tranche 1 of its A\$205 million equity raise announced on 25 September 2025. The Company raised A\$35.6 million (before costs) from institutional, sophisticated and professional investors via the placement of 136,923,077 new fully paid ordinary shares ("Placement Shares") at an issue price of A\$0.26 per share.<sup>4</sup>

The Placement Shares were issued on 2 October 2025, utilising the Company's existing placement capacity under Listing Rule 7.1 and rank equally with the existing fully paid ordinary shares on issue.

Tranche 2 of the equity raise, comprising of a conditional placement to Eagle Eye Asset Holdings ("EEA") and Afriland Bourse & Investissement ("Afriland") is expected to raise an additional A\$170 million through the issue of 653 million shares at an issue price of A\$0.26 per share. Tranche 2 of the equity raise is subject to shareholder approval, which will be sought at the forthcoming Annual General Meeting expected to be held in November. In addition to shareholder approval, Afriland's participation in Tranche 2 of the equity raise is subject to various in-country regulatory approvals.

In addition to the equity raise, EEA has committed to exercising approximately 137 million options at an exercise price of A\$0.07 to raise approximately A\$10 million. The Company anticipates receiving the A\$10 million and completing the option exercise in the coming weeks.

The Company finds itself with a strong pro-forma balance sheet, with A\$175 million in undrawn debt and A\$266 million in cash following the raise.

### ASX Listing Rule Information

In accordance with ASX Listing rule 5.3.1, the Company advises that expenditure on exploration activities for the Quarter totalled A\$10.0M as disclosed in the accompanying Appendix 5B and was focused on the completion of the DFS.

In accordance with ASX Listing rule 5.3.2, the Company advises that there was no expenditure on mining production and that expenditure on development activities for the Quarter totalled A\$10.8M as disclosed in the accompanying Appendix 5B. This development expenditure related to the ordering of rolling stock, haul road and IRF construction as well as engineering design work related to the rail for the development of Minim Martap.

- No farm-in or farm-out agreements were entered into during the Quarter; and

Following granting of the Mining Permit for the Minim Martap mining areas, in accordance with Section 59 of the Mining Code, an entity of the State will be granted 10% ownership of the special purpose Joint Venture Company formed for that purpose, free of charge.

#### About Canyon Resources

Canyon Resources is developing its flagship Minim Martap Bauxite Project in Cameroon, which contains over 1.1 billion tonnes of high-grade, low contaminant bauxite, with significant exploration upside. Minim Martap ranks among the world's richest bauxite deposits, with an Ore Reserve of 144Mt at 51.2% Al<sub>2</sub>O<sub>3</sub> and 1.7% SiO<sub>2</sub> and a JORC Mineral Resource Estimate of 1,102Mt at 45.3% Al<sub>2</sub>O<sub>3</sub>.

Minim Martap is a world-class Project supported by a Definitive Feasibility Study released in September 2025. Results from the DFS confirmed Minim Martap as a robust long-term project, containing some of the highest-grade bauxite globally for an initial 20 years of mining.

The 20-year mining schedule represents only 13.1% of the current Minim Martap Resource and technical studies have identified opportunities for a significant future increase in the production target.

Cameroon has enjoyed successful development and construction of industry and infrastructure, particularly agriculture, roads, railways and ports, including a hydro-electric powered aluminium smelter at Edea, utilising imported alumina. Importantly, Cameroon provides a solid foundation to support a significant mining industry, from fundamental infrastructure and mineral deposits to a highly skilled population with experience in technical vocations, exploration, construction and mining.

#### Mineral Resources and Ore Reserves

This announcement contains estimates of the Mineral Resources and Ore Reserves estimated for the Project.
