The facility was fully drawn in December 2024. The loan holds senior security customary for a facility of this nature. The interest rate is Bank Bill Swap Rate (Bid) plus a margin of 2.00% per annum. Interest capitalises for the first 18 months of the loan. The loan has a grace period of 18 months from drawdown date. <p>Develop has equipment financing facilities with:</p> <ul style="list-style-type: none"> Sandvik, CBA, Epiroc, Cat Finance and NAB – the total combined limit of these facilities is \$108.0M AUD with \$57.5M AUD still available at 30 September 2025. Each of the loans within these facilities secured against the item of equipment financed with the maturity date varies depending on the equipment but they range from 30 months to 36 months from the start of each loan. The weighted average interest rate across the \$50.6M AUD drawn from these facilities is 7.10%.
