Summary;

- A copy of the Appendix 4C Quarterly Cash Flow Report for the 3 months ending 30 September 2025 is included with this update
- Both GTV and revenue were impacted by poor weather along the Australia east coast during the period but are now building into the summer season in ANZ.
- The new NSW TAP program has commenced roll out but the rate of van delivery is very slow at this time.
- Cash expenditure for the period includes operating costs (\$17.4m), staff costs (\$3.2m) and administration and corporate costs (\$2.6m). The reductions in the cost base remain on track. Reduced marketing expenditure (\$1.2m) remains effective.
