Quarterly Activities Report**Q2 FY26 headlines:**

Wingara AG Limited (ASX: WNR), is pleased to provide its 30 September 2025 quarter's activities report alongside its Appendix 4C (Quarterly Cashflow Report) for the six months ended 30 September 2025 (Q2 FY26).

As previously announced, Wingara ceased its processing operations on 14 November 2024 and further announced the sale of its main machinery and auxiliary components on 27 February 2025. The machine is expected to be dismantled and removed from the Epsom site in the coming weeks and has already been transferred to the new owners.

Site obligations including ongoing property lease payments will continue to occur until the lease expires in February 2026. Wingara continues to provide storage services on the Epsom site.

Current cash and cash equivalents as at 30 September 2025 were \$302k with a focus on cost control and managing its remaining liabilities and obligations.

Wingara continues to work through several transaction opportunities that have been presented to it post conclusion of the Terra Firma Equity Limited opportunity, as announced on 19 August 2025.

In accordance with ASX Listing Rule 4.7C.3, payments to related parties and their associates outlined in the Company's Appendix 4C for the quarter relate to fees and salaries paid to Directors.
