



## QUARTERLY ACTIVITIES REPORT FOR THE PERIOD ENDING 30 SEPTEMBER 2025

### Key Highlights

- **Environmental approvals** granted across Argentine exploration projects — Cerro Chacón South and Middle (approved last quarter) and Sierra Cuadrada (approved this quarter) — marking a major regulatory milestone and clearing the path for drilling.
- **Cerro Chacón (Epithermal Gold/Silver, Chubut):** The drill rig has been secured, contract awarded and payments made, and weather conditions now favourable for the Company's initial ~8,500-metre RC program. The program design was refined in July to incorporate recently received geochemical results, which identified extensions to existing anomalies and improved drill-hole prioritisation. Approximately 20 km of access tracks completed and 30 drill pads prepared for the ~60-hole campaign. Drilling to commence October 2025.
- **Sierra Cuadrada (Uranium, Chubut):** Exploration EIA approved, clearing the way for drilling once surface-access agreements are finalised. Target refinement and stakeholder engagement advanced, positioning the project for 2026 field activities.
- **Ashburton (Uranium, Western Australia):** Review of RC drilling results underway, with follow-up targets being prioritised.
- **Stakeholder engagement:** Constructive progress achieved in land-access negotiations at Sierra Cuadrada; engagement continues to emphasise environmental stewardship and phased exploration.

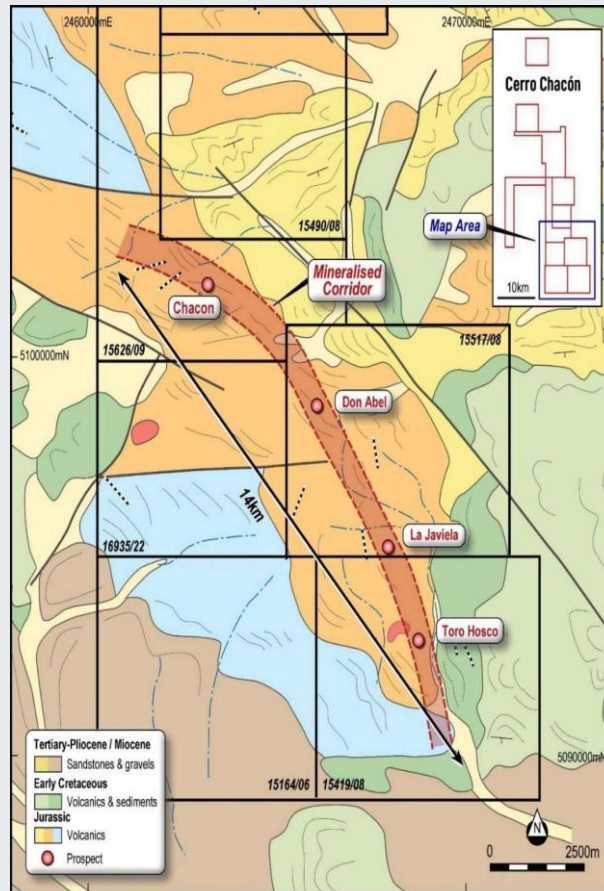
### ARGENTINA

#### Cerro Chacón Gold/Silver Project (Chubut Province)

The Exploration Environmental Impact Assessment (EIA) reports for Chacón South and Chacón Middle were formally approved last quarter, enabling Piche Resources to commence all ground-disturbing activities across its principal tenements. Following winter delays, favourable weather conditions now allow drilling to begin in October.

With approvals secured, pre-drilling preparations in progress, and the program refined to integrate new geochemical results received in July. These results highlighted several extensions to previously defined anomalies, resulting in an optimised drill layout focused on the highest-priority targets.

Key preparatory milestones include:

- ~20 km of access tracks constructed.
- Drill pads for 30 holes (~50% of total) completed, with the remaining in progress.
- Conosur Drilling S.A. appointed as contractor; mobilisation scheduled next quarter

The maiden RC drilling program comprises ~60 holes for ~8,500 m, updated in July based on the new geochemical dataset, and will test a 14 km-long mineralised corridor defined by coincident geochemical and geophysical anomalies across three main prospects.

The prospects occur within a large low-sulphidation epithermal system analogous to Cerro Vanguardia and Cerro Negro. Geochemical sampling, detailed mapping and integrated geophysics have delineated multiple structural corridors containing quartz-chalcedony veining and extensive alteration halos. Drilling will commence Q2 FY25/26, with results expected to underpin systematic resource definition along the broader corridor.

#### **Sierra Cuadrada Uranium Project (Chubut Province)**

Exploration during the quarter focused on target refinement and stakeholder engagement

The EIA for exploration at Sierra Cuadrada was approved during the quarter, clearing the way for drilling once surface-access agreements are finalised. Discussions with landholders continue to progress constructively, centred on phased work programs, low-impact methods, and transparent environmental standards.

#### **AUSTRALIA**

##### **Ashburton Uranium Project (Western Australia)**

No field drilling was conducted during the quarter. Work centred on integration of assay data from the 2024 RC program and ranking of follow-up targets within the system along and adjacent to mid/lower Proterozoic unconformity. Preliminary interpretation indicates multiple mineralised horizons, continuity of uranium mineralisation along strike, and several areas warranting step-out or deeper drilling.

#### **CORPORATE**

- ESG & Community: Engagement with Patagonian landholders continued constructively, reinforcing Piche’s commitment to phased exploration, environmental care, and long-term relationships.

#### **OUTLOOK**

During Q2 FY2025/26, Piche Resources will focus on:

- Commencing maiden RC drilling at Cerro Chacón and reporting initial progress.
- Finalising access agreements at Sierra Cuadrada to enable 2026 drilling.

- Completing target prioritisation at Ashburton for the 2026 program.
- Continuing to advance ESG, safety, and stakeholder programs across both jurisdictions.

With regulatory approvals secured, contracts awarded, payments made, and operations mobilising, Piche Resources enters FY2025/26 strongly positioned to deliver multiple near-term catalysts and advance its portfolio of Tier-1 discovery opportunities.

## **Other business**

On 29 July 2025, the Company announced the appointment of Ms Karilyn Farmer as Managing Director with effect from 18 August 2025.

On 18 August 2025, the Company issued 6 million performance rights to Ms Farmer in relation to her commencement of employment.

On 29 September 2025, the Company released its annual report and corporate governance statement to shareholders.

As of 30 September 2025, the Company held A\$4.2 million in cash. Full details of the Company's cash movements during the Quarter are detailed in the attached Appendix 5B.

As per ASX Listing Rule 5.3.1, incurred exploration expenditures were primarily related to exploration work at the Argentina projects. Exploration expenditures incurred during the Quarter are reported at A\$215,000.

As per ASX Listing Rule 5.3.2, there were no substantive mining production and development activities undertaken during the Quarter.

In accordance with Listing Rule 5.3.5, the Company advises that payments made to related parties as disclosed in the Appendix 5B for the Quarter were A\$226,000 for Director fees and salaries.
