

Correction – Date of Second Court Hearing

Locate Technologies Limited (ASX: LOC) (“Locate Technologies” or the “Company”) wishes to advise of amendments to the announcement made earlier today on 11 November 2025 titled “Notice of Second Court Hearing”, which amendments are included in the attached revised announcement.

The following amendments have been made:

Notice of Second Court Hearing

Locate Technologies Limited (ASX: LOC) ("Locate Technologies" or the "Company") provides the following update in relation to the proposed acquisition by Locate Technologies Limited (a company incorporated in New Zealand) ("Locate NZ") of all of the shares in Locate Technologies, by way of a scheme of arrangement.

Locate Technologies refers to the explanatory statement, which includes information about the Scheme and the notice of Scheme meeting, released to the ASX on Friday, 31 October 2025 ("Scheme Booklet").

If you wish to oppose approval of the Scheme by the Court at the Second Court Hearing, you must file with the Court, and serve on Locate Technologies, a notice of appearance in the prescribed form, together with any affidavit on which you wish to rely at the hearing. The notice of appearance and affidavit must be served on Locate Technologies at its address for service at least 1 day before the date fixed for the Second Court Hearing.
