Director Retirements

The Company advises that Mr Richard Bund and Dr Hyungtae Kim will retire from the Board at the 2025 AGM on 19 November 2025. Both Mr Bund and Dr Kim remain supportive of Microba, its leadership and strategic direction as the Company advances its next phase of growth.

Mr Bund has served as a Non-Executive Director since 2018 and has made a significant contribution to Microba’s governance and strategic evolution. He chaired the Nomination and Remuneration Committee and was a member of the Audit and Risk Committee. Mr Bund has played a key role in guiding the Company through its early commercialisation phase and its successful transition to a listed entity in 2022.

Dr Kim joined the Board in 2019 as a representative of MacroGen Inc., which provided strategic and financial support to Microba through its formative years. His scientific and international perspective have been invaluable as the Company developed and expanded its core microbiome technology platform.
