Release of Revised Annual Report for Financial Year Ended 30th June 2025

Perth, Australia: Alara Resources Limited (“Alara”) lodges a revised Annual Report for the financial year ended 30 June 2025 (“Revised Annual Report”), with the ASX.

Following a routine post-release review and in consultation with the ASX, it was identified that certain mandatory disclosures were inadvertently omitted from the previously released version. These have now been incorporated to ensure full compliance with the ASX Listing Rules and the relevant reporting requirements for exploration and mining entities.

The Revised Annual Report includes additional information in relation to, amongst other items, Alara’s recent mineral resource and reserve update, as well as explanatory notes to address unintended minor administrative omissions and errors which arose primarily due to change in key personnel during the finalization process of the original report. The amendments are aimed at providing enhanced visibility to stakeholders and do not affect the underlying financial results, audit opinion, or overall conclusions presented in the previously released report.

The Board wishes to emphasize that the re-release reflects Alara’s ongoing commitment to transparency, strong governance, and full regulatory compliance. Preparation of the revised report was undertaken in close coordination with ASX to ensure Alara’s reporting remains exemplary and consistent with the best practice disclosure standards.

Alara appreciates the ASX’s constructive engagement on this matter and reaffirms its dedication to maintaining the highest standards of corporate governance, reporting integrity, and stakeholder confidence.
