## **SRG Global secures \$650m of contracts in diverse sectors across Australia and New Zealand**

### **Highlights:**

- **SRG Global secures \$650m of contracts with blue-chip clients across Australia and NZ**
- **Contracts secured in Water, Defence, Transport, Energy, Industrial, Resources, Health and Education sectors**

SRG Global Ltd ('SRG Global' or 'the Company') (ASX: SRG) is pleased to announce it has been awarded \$650m of contracts with blue-chip clients across a diverse range of sectors, including:

### **Water**

- Design and construction of concrete tanks for the Alkimos Seawater Alliance (consisting of Water Corporation, Acciona and Jacobs) associated with the Alkimos Desalination Plant Project in Perth, Western Australia (WA). The contract has commenced and is expected to be complete within 17 months; and
- Water infrastructure contract with Byron Shire Council for flood resilience works, including stormwater drainage upgrades in Byron Bay, New South Wales (NSW). The contract has commenced and is expected to be completed in December 2026.

### **Defence and Transport**

- Specialist bridge rehabilitation and maintenance works at the San Remo Bridge in Victoria (VIC) through the Program Delivery Approach contract model with VIDA Roads. Works on the project development phase have commenced and are expected to last approximately four months; and
- Ongoing infrastructure works in the Defence sector in WA expected to be completed in 2026.

### **Energy**

- Renewable energy infrastructure contract with Fortescue for the delivery of specialist earthworks and civil services at the Bonney Downs Wind Farm in the Pilbara region of WA. The contract will commence immediately and will complete in April 2026.

### **Industrial and Resources**

- A five-year term contract, with Wesfarmers Chemicals, Energy & Fertilisers to provide specialist major shutdown maintenance services across its CSBP Kwinana operations in WA. The contract has commenced and will complete in July 2030;
- A seven-year term contract, with South32 to provide specialist maintenance services across its Worsley Alumina operations in the south-west of WA. The contract has commenced and will be completed in August 2032;

- A five-year term contract for the Bugarrba Aboriginal JV with Roy Hill to provide specialist shutdown and maintenance services at its Roy Hill mine operations in the Pilbara region of WA. The contract has commenced and will complete in August 2030;
- A four-year term contract, with Tianqi Lithium Energy Australia to provide specialist shutdown and maintenance services at its Kwinana operations in WA. The contract has commenced and will complete in September 2029;
- A five-year term contract, with Alcoa to provide multi-disciplinary maintenance services across its Pinjarra and Wagerup operations in the south-west of WA. The contract will commence in December 2025 and be completed in early 2030;
- Appointment to Rio Tinto Sustaining Capital Master Construction Agreement Panel for Pilbara based bulk earthworks & civil services, effective immediately. The contract has commenced and will complete in August 2030; and
- Minesite infrastructure contracts for the construction of Section 4 and 2A of Marble Bar Road and the delivery of a skyway and associated civil infrastructure at the McPhee mine-site in the Pilbara region of WA. The contracts have commenced and will be completed in April 2026.

## Health and Education

- Specialist facade contracts with Lendlease at the Melton Hospital (VIC) and University of WA Nedlands Student Accommodation (WA) developments. Additional contracts with Multiplex for the Bunbury Hospital (WA) and CPB for the New Dunedin Hospital Inpatient Building in New Zealand. The contracts have commenced and will be completed in November 2028.

David Macgeorge, SRG Global Managing Director, commented: “We continue to secure a diverse range of contracts across Australia and New Zealand in a broad range of sectors with both key repeat and new clients. These contract awards are a further demonstration of our market-leading capabilities as a truly diversified infrastructure services company.

“I am particularly pleased that the combined specialist bridge strengthening and improvement capabilities of our Asset Remediation team, together with the marine infrastructure services capabilities of our TAMS business, have enabled SRG Global to secure new contracts through collaborative arrangements with our clients.
