# EOS STATEMENT ON SETTLEMENT OF ASIC INVESTIGATION

Electro Optic Systems Holdings Limited ("EOS" or "Company") (ASX: EOS) today announces that it has settled ASIC's investigation in relation to certain disclosure matters in 2022. The settlement includes an agreed proposed penalty of \$4 million for the approval of the Federal Court.

## BACKGROUND

As previously disclosed in an Investor Presentation on 22 March 2024, and referenced in the Company's 2023 and 2024 Annual Reports, EOS has been the subject of an investigation by ASIC in connection with the Company's 2022 revenue guidance.

The Company navigated a challenging environment in 2022 marked by strategic, financial, and operational pressures. Significant business and leadership changes were made towards the end of that year, including the appointment of Garry Hounsell as Chair, Dr Andreas Schwer as CEO and Clive Cuthell as CFO, along with the addition of Robert Nicholson in 2023 as a non-executive director.

## SETTLEMENT WITH ASIC

The Company has reached a settlement with ASIC in connection with alleged breaches by the Company of continuous disclosure obligations under the Corporations Act 2001 (Cth) and the ASX Listing Rules. The settlement brings to an end ASIC's investigation into the Company's 2022 revenue guidance.

The Company accepts ASIC's conclusion that it breached its continuous disclosure obligations in the period from 25 July 2022 to 31 October 2022. The Company announced on 8 September 2022 that delivery against existing contracts had been impacted by supply chain constraints, the awarding of new contracts had been slower than expected and that the Company was reassessing its financial outlook. Updated revenue guidance for 2022 was provided on 31 October 2022.

EOS has cooperated with ASIC throughout the course of the investigation. As part of the settlement, ASIC has applied to the Federal Court seeking declarations of contravention of continuous disclosure obligations and a civil penalty of \$4 million. EOS supports the declarations and penalty sought by ASIC.

ASIC has indicated that it intends to bring separate proceedings against Dr Ben Greene (former CEO and current Chief Innovation Officer of EOS) in relation to the same revenue guidance issues. Dr Greene is not a party to the settlement.

## COMPANY STATEMENT

The Company recognises the importance of meeting its continuous disclosure obligations and remains committed to upholding high standards of corporate governance and transparency. Garry Hounsell, Chair of the Company, said:

*"This outcome represents a constructive resolution with ASIC that allows the business to move forward with clarity, removing the potential of protracted litigation on the matter. We believe this outcome is in the best interests of the Company and its shareholders. Since late 2022, we have made significant progress in strengthening our business and remain committed to best-practice and transparent communication. As we look to the future, we are well-positioned to execute our strategic priorities and deliver long-term value for our shareholders"*
