Chair's Address

2025 Annual General Meeting

Good morning, I'm Anne-Marie Birkill and it is my pleasure to welcome you to my second AGM as the Chair of your company. This is our first fully virtual AGM, and we have a fresh approach to providing you with updates on how each of our underlying portfolio companies are performing. Later in today's presentation, you will hear directly from the company leaders in a series of pre-recorded videos. We trust you find them informative and welcome your feedback on this new format.

I begin by acknowledging the Turrbal and Yuggera peoples as the Traditional Custodians of Meanjin. I pay my respects to their ancestors and Elders, past and present. I acknowledge our indigenous peoples as the first innovators of these lands and express my admiration for their ingenuity.

I acknowledge my fellow directors, Glenn Molloy, Rick Francis and Marc Fenton.

PPK continues to refine its mandate and develop a plan to pivot to a new position in the market. This process has necessarily included a reconciliation of our assets and a redefinition of our business model.

Our investment mandate, based on the opportunities we see in the market, and the performance of our existing portfolio, is to invest in innovative, growth stage companies, with the potential to address global markets, where our state-of-the-art Australian facilities deliver sovereign manufacturing capability.

Through the 2025 financial year we continued to execute on our plans to reposition PPK. Both the divestment of AMAG and the deconsolidation of LIS, the latter returning \$5.19M in fully franked dividends to PPK shareholders via an *in specie* distribution of LIS shares, are consistent with this objective.

We are pleased to report that Craig International Ballistics has once again been the clear stand-out performer in the last 12 months generating \$48 million in revenue, its highest in 25 years of operations. This is an outstanding result and a credit to CEO James Craig and the CIB Team.

PowerPlus Energy's revenue was slightly down this period in a competitive market but the company continues to hold significant market share, and the Cheaper Home Battery Program has stimulated new demand.

The nanomaterial merger ensures sufficient resources are in place to support their commercialisation journey. While there is still considerable risk, we believe the team has the capital and expertise to support the industry collaborations in its pipeline.

LIS continues to make good progress, commissioning the Phase 3 production line, achieving world-class energy density data for its proprietary lithium sulfur cells, flying the first drone powered by its cells and signing significant new commercial collaborations.

We feel confident that our focus on investment in growth stage companies participating in the transition to renewable energy, providing armour protection and applying proprietary nanomaterials to solve the challenges of industry is well aligned with our investment mandate.

Looking to the future, we are focused on continuing to strengthen the performance of the existing portfolio of investments while looking for new opportunities to expand PPK's footprint in energy storage. Through the year we assessed several growth opportunities, but none proceeded beyond preliminary due diligence.

I'll now hand over to Managing Director Marc Fenton for a more detailed portfolio update before we move to the more formal part of the meeting. Shareholders will be aware that Marc will be leaving PPK in early December to take a break and then pursue new opportunities. We thank Marc for his leadership and contribution to the business and wish him well for the future. The CEO responsibilities will be split between the Board and Executive team whilst we assess the capabilities required to lead PPK going forward.

In closing, thank you once again for your support.

PPK Group FY25 summary

- Li-S Energy deconsolidated on 31 October 2024 simplifying the balance sheet for shareholders. PPK delivered a return to shareholders via a fully franked in-specie dividend to PPK shareholders valued at \$5.2m (**5.71 cents per share**)
- CIB achieved record revenue of **\$48.1m**, it's highest in 25 years of operations
- LIS **commissioned Phase 3 facility** and achieved a world-class **456 Wh/kg** post formation energy density
- PPE delivered new **CEC approved products**, reduced costs but revenue was slightly down due to introduction of Cheaper Home Battery program, which did not commence until 1 July 2025
- Nanomaterials focused on target market engagement and evaluations
- Exit of PPK 30% share of AMAG investment
- Appointment of Rick Francis to the PPK Board and now chairs the Audit and Risk Committee

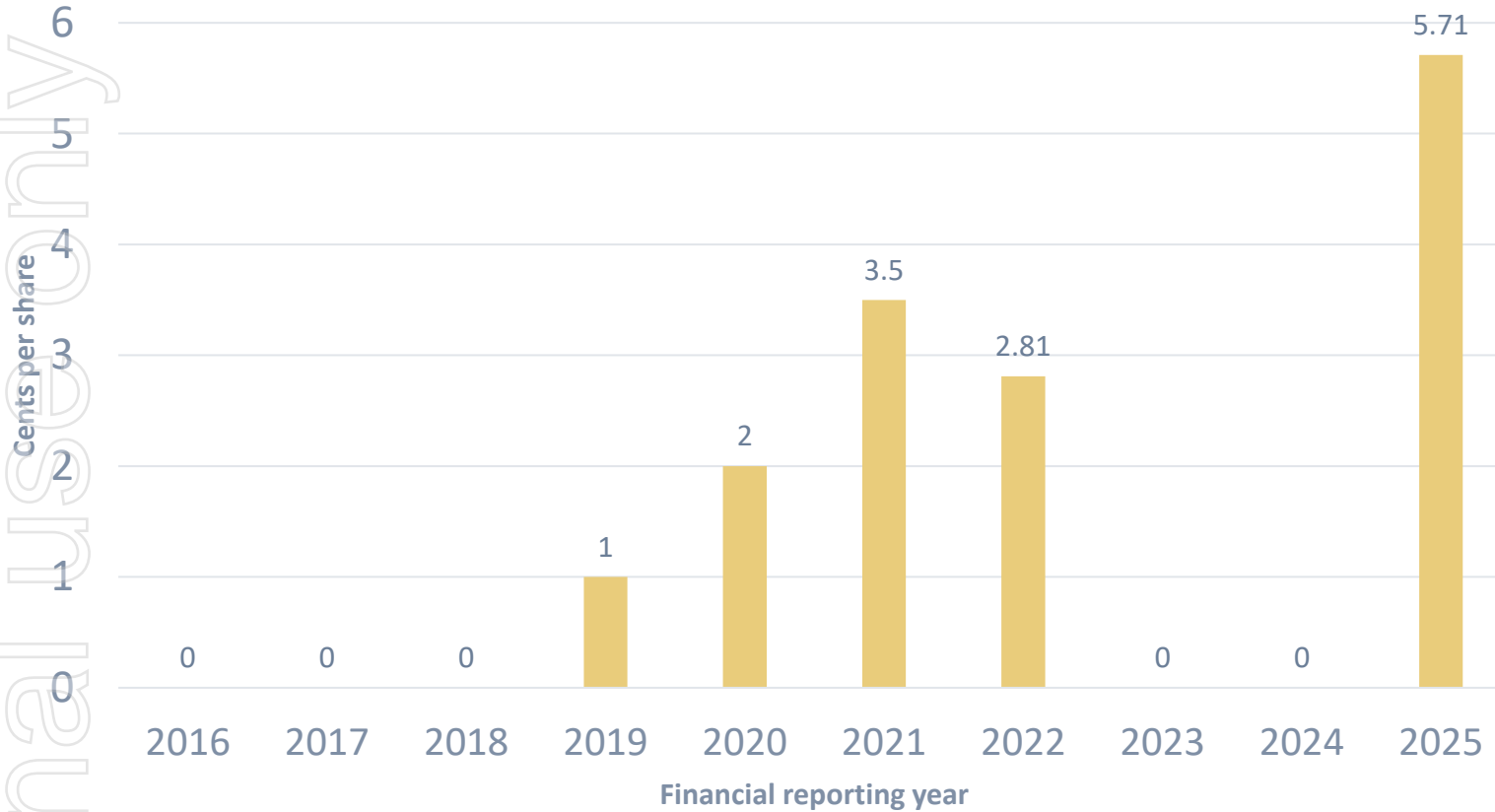
