

## NMPA secured for China Hearing Aid Launch

This announcement follows previous updates regarding the partnership and purchase order arrangements with Eastech:

Achieving NMPA certification confirms full regulatory compliance and positions the product for **large-scale commercial rollout**, including visibility across China's **top-tier e-commerce marketplaces**, which dominate national hearing aid purchasing behaviour.

“Securing NMPA certification is an important achievement for our partnership with Eastech and a strong validation of our proprietary hearing personalisation technology. It reinforces the commercial potential of this product in a **high-growth hearing aid market**, strengthens our strategic collaboration with Eastech, and enhances Audeara's pathway to delivering **repeatable, high-margin licensing revenue**.”

The certification enables Eastech to commence production and activation planning ahead of launch. Under the licensing arrangement, Audeara will receive technology licensing revenue per unit sold as commercial rollout occurs.

This milestone **supports Audeara's global licensing and commercial expansion strategy**, strengthens the Company's position in the **rapidly growing hearing health technology sector**, and is expected to contribute to **scalable, recurring licensing revenue** as the product enters China's **high volume, market-leading e-commerce ecosystem**.
