

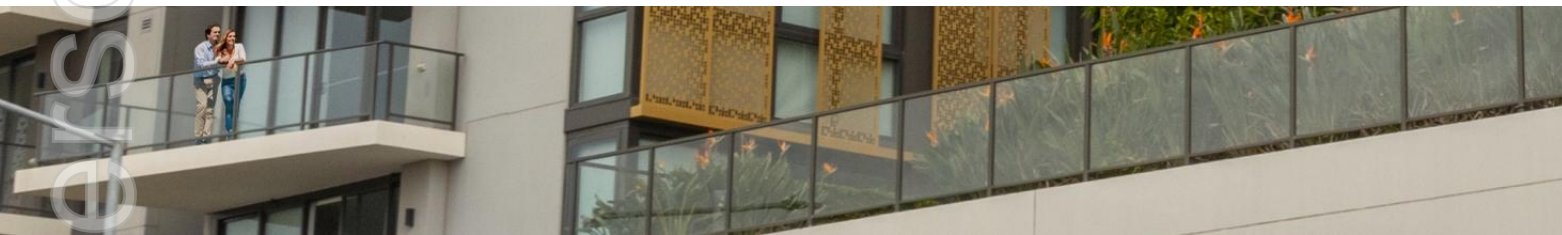

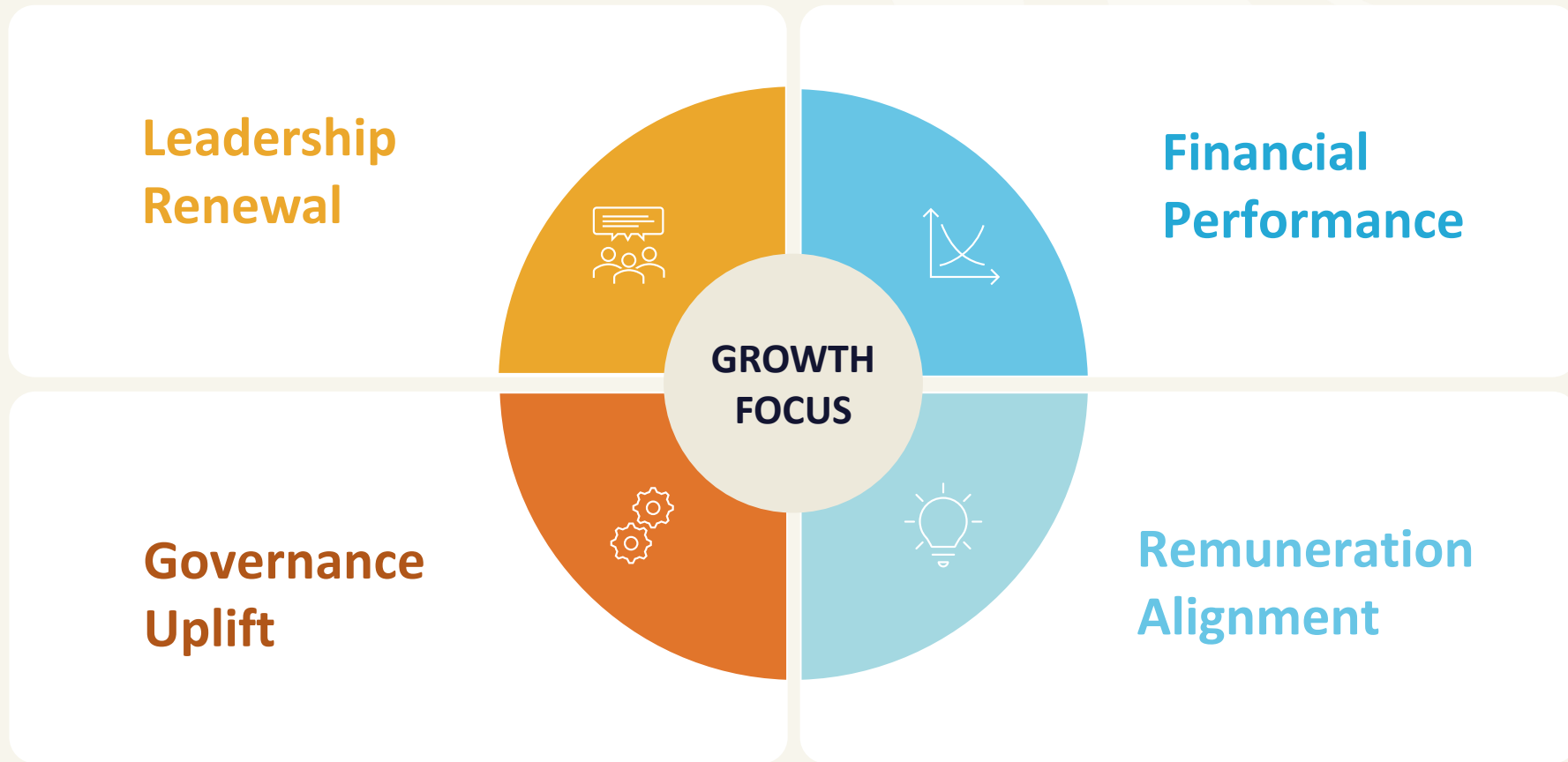

LPE delivered 5,711 new service points, representing 84% of the FY2025 target of 6,798 as follows:



Greenfield developments: 1,457 new service points
