The Gorman Project is located within the **Bearhead Lake Fault Zone** in north-western Ontario, the same structural corridor hosting Frontier Lithium's **PAK–Spark Project**, now recognised as a **nationally strategic lithium asset** by both government and major industry partners.

# High-Grade Lithium Discovery

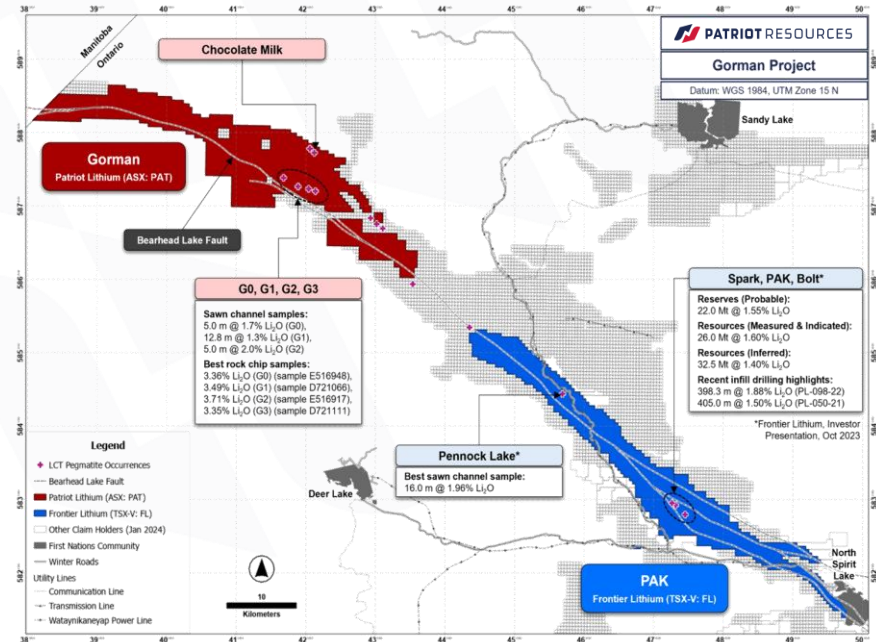
## Confirmed Spodumene-Bearing LCT Pegmatite System, Open in All Directions

The Gorman Project hosts a confirmed lithium-caesium-tantalum (LCT) pegmatite system, comprised of multiple outcrops (G0-G3) forming a 5.2 km-long spodumene-bearing trend, open in both directions.

### Sampling highlights:

- 5.0 m @ 2.0 % Li<sub>2</sub>O (G2)  
12.8 m @ 1.3 % Li<sub>2</sub>O (G1)  
5.0 m @ 1.7 % Li<sub>2</sub>O (G0)
- High-grade rock chip sampling underpins the trend, with values of **>3 % Li<sub>2</sub>O** (up to 3.7 % Li<sub>2</sub>O) in outcrops across the G0-G3 pegmatites.
- The current drill permit from the Ontario Ministry of Mines covers up to 2,400 m of drilling across the project area, signaling the move from surface exploration into the subsurface domain.

# Proven Lithium District

## Frontier Lithium, Tier-1 Strategic Validation

Gorman lies within the same geological corridor as Frontier Lithium's PAK–Spark Project, which is now being advanced as Ontario's first fully integrated lithium chemicals operation, backed by global industry and government capital, confirming the strategic importance of this district.

- **Mitsubishi Corporation as cornerstone strategic partner** - C\$25M for 7.5% of PAK / Spark, with the right to increase to 25%
- **Government-backed critical minerals project** - up to C\$6M funding awarded from Canada's Critical Minerals Infrastructure Program
- **Downstream commitment underway** - Frontier has commenced a Definitive Feasibility Study (DFS) on its lithium conversion facility in Thunder Bay (site acquired Feb 2025)
- **Frontier advancing district-scale development strategy** – drilling confirms multiple PAK–Spark satellite discoveries along same Bearhead Lake corridor
- **Frontier's 2025 Feasibility Study:** approx. 200,000 tpa SC6, after-tax NPV<sub>8</sub> ≈ C\$932M

**Patriot holds a dominant land position on the northern extension of the same lithium corridor.**

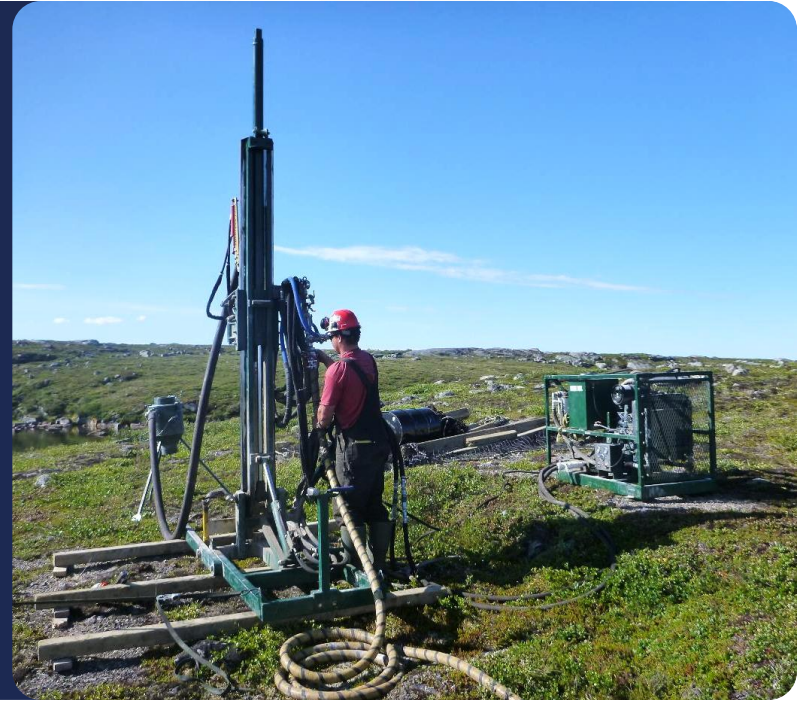

# Pre-Resource, Fully De-Risked and Development-Ready

Gorman is positioned at the same stage Frontier Lithium (TSXV: FL) was in prior to its resource discovery.

- High-grade spodumene confirmed across a 5.2 km corridor
- Located within the same lithium growth corridor now being advanced by Frontier toward integrated mine + conversion production
- Ontario already validated by Tier-1 buyers and Canadian federal funding mechanisms

**This is a structurally advantaged lithium asset at the pre-valuation re-rate inflection - fully permitted, strategically located**
