The securities are unquoted fully paid ordinary shares in Wesfarmers Limited, ranking equally with other Wesfarmers ordinary shares but with payment of dividend entitlements deferred until quotation.

Under the terms of the KEEPP, 134,300 securities will be allocated as Deferred Shares and 134,300 securities as Performance Shares. Deferred Shares are subject to a one-year service period and Performance Shares are subject to a four-year performance period. Once the shares have vested at the end of the service or the performance period (as applicable) the Company will seek their quotation.

Of the shares issued under the KEEPP for this allocation, 220,956 shares have been issued to persons who are KMP at the time of allocation, with the remaining 47,644 shares issued to participants who are not current KMP. These totals are split equally between Deferred Shares and Performance Shares.
