Trading Halt Request

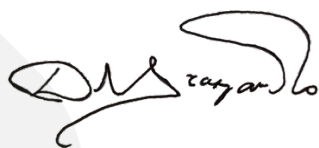
Pursuant to ASX Listing Rule 17.1, Talga Group Ltd ("**Company**") requests a trading halt in respect of the ordinary shares of the Company (ASX:TLG) commencing immediately.
