## Letter of Intent with ALKEEMIA Graphite Purification Tolling Services

**International Graphite Limited (ASX: IG6) (FWB: H99)** is pleased to announce it has signed a non-binding letter of intent with Alkeemia S.p.A ("**ALKEEMIA**") for ALKEEMIA to provide toll treatment graphite purification services.

ALKEEMIA is one of Europe's largest producers of hydrofluoric acid and fluoroderivatives from its operations in Port Marghera (Venice, Italy).

ALKEEMIA plan to commence operations at their 200 t/y Industrial Graphite Purification Plant in quarter 1 2026. International Graphite has been allocated up to 50% of the start-up processing capacity and will seek to increase supply as the facility ramps up to its name plate processing capacity.

Managing Director and CEO Andrew Worland said partnering with ALKEEMIA on purification services could be transformational for the Company's plans.

"High-purity graphite is critical to accessing higher value micronised and expandable graphite products and essential for anode supply," he said.

"Access to commercial toll treatment services would remove considerable capital expenditure and operational risk as we scale our operations and product suite."

ALKEEMIA is targeting a phased expansion of its graphite purification capacity, with operations commencing in 2026 and scaling to 20,000 t/y by 2030.

The Company and ALKEEMIA are exploring ways in which the respective business can achieve further integration to deliver capital and operating efficiencies.
