

## Janison secures landmark \$21 million contract in New Zealand

### Highlights

- New Zealand Ministry of Education awards Janison a major five-year national contract valued at ~A\$21 million (NZ\$24 million) to deliver the Student Monitoring, Assessment and Reporting Tool (SMART).
- SMART will support twice-yearly, bilingual assessments for students in Years 3–10 across reading, writing, maths, pānui, tuhituhi and pāngarau.
- Delivered via Janison's online assessment platform.
- Agreement represents one of Janison's most significant international wins, expanding its role in delivering digital assessment solutions for national education systems beyond Australia.

**Janison Education Group Limited (ASX: JAN)** ("Janison" or the "Company"), has secured a major five-year multi-services Agreement valued at ~A\$21 million (NZ\$24 million) with the New Zealand Ministry of Education to deliver the Student Monitoring, Assessment and Reporting Tool (SMART).

This assignment is a major national initiative, supporting twice-yearly assessments for students in Years 3 to 10 across reading, writing, maths, pānui, tuhituhi and pāngarau. SMART will play a central role in New Zealand's assessment, aromatawai, reporting and monitoring activity, delivering a bilingual approach to understanding student learning progress across Aotearoa. Work on the assignment commenced via a bridging contract in July 2025 and will continue under the newly executed five-year agreement.

The world-class bilingual SMART will be delivered using Janison's secure and scalable online assessment platform, providing a long-term digital foundation for national assessment in New Zealand.

The five-year agreement total contract value (TCV) of ~A\$21 million (NZ\$24 million) reflects the minimum committed contract revenues over the term. It is subject to standard termination provisions as well as termination for convenience. Year 1 revenue is estimated at approximately A\$3.0m. Additional project components and service work are expected to be commissioned via Statements of Work (SOWs) during the contract term and are not included in the contracted TCV.

Sujata Stead, CEO of Janison, said: *"This agreement represents one of Janison's most significant international wins, demonstrating the relevance and scalability of our solutions beyond Australia. We're proud Janison has been selected to partner with the New Zealand Ministry of Education on such an important national initiative, and we look forward to supporting the Ministry in delivering a secure, scalable and culturally responsive assessment experience for learners across Aotearoa."*
