

## Lotterywest awards contract for gaming and digital solution to Brightstar Lottery

Jumbo Interactive Limited (ASX: JIN) (Jumbo) refers to today's announcement by Lotterywest that it has awarded a contract for the development, implementation and support of a gaming solution and digital solution to replace its existing gaming and digital solutions platform to Brightstar Lottery PLC (NYSE: BRSL) (Brightstar). Jumbo is pleased to announce that it will work with Brightstar on a subcontractor arrangement to provide components of the solution.

Under the proposed arrangement, Brightstar will provide gaming and digital systems to Lotterywest, including the software and hardware required to support both retail and digital channels. Jumbo will partner with Brightstar to integrate key capabilities from its proprietary Jumbo Lottery Platform (JLP) by supplying the website and mobile applications for the digital system, as well as contributing elements of Jumbo's Player Account Management<sup>1</sup> module to the broader gaming system.

Jumbo's existing SaaS agreement held directly with Lotterywest, through which Jumbo operates the "Lotterywest by OzLotteries" digital channel remains unchanged.

The transition from Lotterywest's existing platform to the new Brightstar-led solution will be executed in phases, with go-live currently targeted for Q3 2027. The timing for delivery of the digital component is expected to follow thereafter, although the precise implementation timeline is still to be determined.

The final terms of the proposed subcontract arrangement between Jumbo and Brightstar remain subject to negotiation and board approval. Jumbo will provide a further update to the market once the subcontract has been executed.
