**Galilee Energy Limited (Galilee, the Company) (ASX: GLL)** announces that the Board has resolved to appoint existing Chief Executive Officer Joseph Graham and each of Eduardo Robaina and Dale Hanna as directors of the Company.

The appointments follow the recently announced acquisition of the Zydeco Gas Project in Louisiana, USA and recognise the importance of aligning the Board's capabilities with Galilee's new strategic direction in Louisiana, along with those of the new and existing shareholders who have supported this change in strategic direction.

The incoming directors will bring fresh perspectives and relevant experience to support and advance that strategy.
