**New Supply Agreements for Re>Pal**

**Significant pallet supply commitments from Yukalt, FKS Food and Mayora**

**Range International Limited** [ASX:RAN, Company or Range] is pleased to announce its subsidiary, Re>Pal Indonesia has signed pallet supply contracts with Marubeni/Yukalt, FKS Food and Mayora.

Re>Pal is pleased to announce a strategic partnership with Marubeni and Yukalt to recycle Yakult's packaging into HDX 1210 CBL pallets for use across Yakult's Indonesian facilities. This initiative plans to deliver pallets valued at IDR 2.625 billion (approximately equivalent to AUD \$238,000) advancing Yakult's sustainability and operational efficiency. Mr Otaki Hideki, Director of Plastics at Marubeni Indonesia, stated "Re>Pal has a unique ability to manufacture heavy-duty pallets using 100% recycled plastics collected from Yakult. This solution enables Yakult's storage operations to adopt a circular approach to plastic waste and enhances operational efficiency by replacing existing timber pallets."

Re>Pal has secured a pallet supply contract with PT FKS Food Sejahtera ("FKS"), a major Indonesian FMCG with consumer brands, cooking ingredients and food and feed products. The total value of this sales contract for HDX1210RL pallets with FKS is IDR 1.35 billion (approximately A\$125,000).

Re>Pal has also secured its first pallet supply contract with PT Tirta Fresindo Jaya ("Mayora"). The Mayora group are a major FMCG and the second largest bottled water producer in Indonesia. The total value of the initial sales contract with Mayora is IDR 1.88 billion (approximately A\$170,000). Mr Ahmad Firdo, Head of Continuous Improvement & Maintenance for PT Tirta Fresindo Jaya (Mayora Group) said, "We chose Re>Pal to produce pallets and plastic separators for use in our bottled water division as Re>Pal was the only vendor that could recycle our plastic packaging into products to replace timber pallets and plywood separators".

There are no material conditions that need to be satisfied before the contracts become legally binding or proceeds to completion.

"These contracts endorse the continued success of Re>Pal's marketing to significant customers of our capabilities to recycle specific types of packaging into sustainably manufactured pallet solutions," commented Re>Pal's Marcus Goldstein. "Our unique process provides key clients with high quality, durable pallets that assist meeting their EPR targets".
