ASX has advised to start a new electronic form as the processing of ASX Online forms was interrupted on 1 December 2025. As previously announced on 21 August 2025, Whitehaven Coal Ltd intends to buy-back up to \$48m of shares between 22 August 2025 and 31 March 2026 within the 10/12 limit. Since 22 August 2025, Whitehaven Coal Ltd has bought back approx 4.5 million shares for a total cost of approx \$30.8 million.
