### Trading Halt Request

European Metals Holdings Limited (**ASX: EMH**) ("European Metals" or the "Company") requests that its securities (ASX Code: EMH) be placed in a trading halt under ASX Listing Rule 17.1, effective immediately.

The Company provides the following information in relation to the request:

1. The trading halt is requested pending the release of an announcement by the Company in relation to a Definitive Feasibility Study ("DFS").
2. The Company requests an immediate trading halt and anticipates that the trading halt remain in place until the earlier of the commencement of trading on Wednesday, 24 December 2025 or the making of an announcement in respect of the DFS.
3. EMH confirms that it is not aware of any reason why the trading halt should not be granted and confirms there is no further information that the Company can inform the market regarding the trading halt.
