## Scheme of Arrangement becomes legally effective

Following the approval of the Supreme Court of New South Wales (**Court**) yesterday of the proposed Scheme of Arrangement (**Scheme**) under which all of the issued shares in Seven West Media Limited (ASX:SWM) will be acquired by Southern Cross Media Group Limited (ASX:SXL) (**Southern Cross**), SWM has lodged an office copy of the orders of the Court with the Australian Securities and Investments Commission (**ASIC**) pursuant to subsection 411(10) of the *Corporations Act 2001* (Cth).

A copy of the Court orders lodged with ASIC is attached to this announcement.

The Scheme is now legally effective and the quotation of SWM Shares on ASX are expected to be suspended from the close of trading today.

On the Implementation Date (expected to be 7 January 2026), SWM shareholders will receive 0.1552 Southern Cross shares per SWM share held at 7:00pm (Sydney time) on 30 December 2025.

This announcement has been authorised to be given to ASX by the Board of Seven West Media.
