32nd Copper Concentrate Shipment Dispatched

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 32nd shipment of copper concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Key Highlights

- **32nd shipment of 1378.6 WMT copper-concentrate shipped on 30th December, comprising 252.6 MT copper and 5.3 Kg gold**

The Al Wash-hi Majaza copper-concentrate plant has achieved a production of 1378.6 WMT of copper-gold concentrate with approximately 252.6 MT of contained copper and approximately 5.3 kg of gold in its latest shipping cycle. This comprises the 32nd parcel of copper-concentrate exported from the plant, and departed Sohar Port on 30th December.
