ISSUE OF SECURITIES - CLEANSING NOTICE

Belararox Limited (“**BRX**” or “**the Company**”) advises that on 2 January 2026, it has issued 35,999,994 fully paid ordinary shares (**Shares**) as completion of tranche 2 of a placement announced on 15 September 2025. The Shares will rank equally with the existing Shares of the Company.

Cleansing Notice

The Company issued the Shares on 2 January 2026 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**).

In accordance with section 708A(5)(e) of the Act, the Company gives notice that:

1. The Shares were issued without disclosure to investors under Part 6D.2 of the Act;

 - a). that has been excluded from a continuous disclosure notice in accordance with the ASX Listing Rules;
 - b). that investors and their professional advisers would reasonably require for the purposes of making an informed assessment of:
 - i. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - ii. the rights and liabilities attaching to the Shares.
