QUARTERLY ACTIVITIES REPORT
PERIOD ENDED 30 SEPTEMBER 2025

ChemX Materials Limited (ASX: CMX) (**CMX** or the **Company**) provides its quarterly activities report for the period ended 30 September 2025.

Corporate

General Meeting and Effectuation of DOCA

The Company completed its Deed of Company Arrangement (“DOCA”), which was formally approved by creditors at the General Meeting of Shareholders (Notice of General Meeting was announced to the ASX on 19 June 2025). Following the effectuation of the DOCA, control of the Company was transferred to a newly appointed board of directors on 18 July 2025.

Response to ASX Appendix 3X Query

During the quarter, the Company responded to an ASX query regarding the late lodgement of the newly appointed Directors (Appendix 3X – Initial Director’s Interest Notices). The delay occurred during a transitional period following implementation of the DOCA and the Company’s recapitalisation, when new Directors and the new Company Secretary were being appointed and governance structures were being re-established.

The Company advised ASX that its existing arrangements under Listing Rule 3.19B remain appropriate, and that the late lodgement was an isolated administrative issue arising from the transition period. The Company reaffirmed its commitment to maintaining robust disclosure and governance practices to ensure continued compliance with ASX requirements.

Suspension from Trading

The Company’s shares remained in suspension from trading on the Australian Securities Exchange (ASX) for the duration of the quarter and, as at the date of this report, remain suspended from trading since 19 December 2024. The Board of Directors are currently taking steps to progress a potential return to trading of the Company’s shares on the ASX in due course.

Funding

During the quarter, the Company has informal financing arrangements in place with a director related entity to cover preliminary operating and business development costs. This funding has provided the necessary liquidity to support the Company’s operational commitments, corporate compliance obligations, and progression of its recapitalisation and restructuring activities following the implementation of the DOCA.

The Company is engaging with the funding party to ensure continuity of support while longer-term capital management and funding initiatives are assessed. The Company remains focused on maintaining prudent financial management and ensuring adequate working capital to support its operational and strategic objectives.

Operational

During the reporting period, no operational, commercial, or corporate development activities were undertaken, aside from those directly related to the finalisation of the Deed of Company Arrangement and the subsequent transition of control to the newly appointed board. No other business initiatives, transactions, or strategic developments were undertaken as the Company remained focused on stabilising its position following the administration process.

Activities of the Company

The Company notes that pursuant to ASX Listing Rule 5.3.1, no exploration activities have occurred during the quarter.

Related Party Payments

In accordance with ASX listing Rule 5.3.5, payments to related parties and their associates outlined in the Company's Appendix 5B for the quarter of approximately \$2k relate to directors' and related party payments.

Upon DOCA effectuation the Company was released from all prior creditor claims. The new directors (also appointed 18 July 2025) are assessing new business opportunities together with appropriate funding sources. In the short term, the Company is relying on informal financing arrangements with a director related entity to cover operating and business development costs.
